INTRODUCTION

1. At its meeting held from 29 to 31 July 1998, the Intergovernmental Group of Experts on Competition Law and Policy recommended that the UNCTAD secretariat be requested to continue to publish an updated version of the Directory of Competition Authorities (agreed conclusions 8 (iii) in annex I of the report of the Intergovernmental Group of Experts on Competition Law and Policy (TD/B/COM.2/13-TD/B/COM.2/CLP/4)(?).

2. Accordingly, the present document contains a revised version of the Directory of Competition Authorities, which could be used to facilitate contacts between officials responsible for the control of restrictive business practices in the performance of their duties.
