INTRODUCTION

The Fifth United Nations Conference to Review all Aspects of the Set of Multilaterally Agreed Equitable Principles and Rules for the Control of Restrictive Business Practices, held from 14 to 18 November 2005, **as well as the Intergovernmental Group of Experts on Competition Law and Policy, which held its seventh session from 31 October to 2 November**, requested the UNCTAD secretariat to continue to publish an updated version of the Directory of Competition Authorities. **(See the resolution adopted by the Review Conference (TD/RBP/CONF.6/14) and the agreed conclusions of the Intergovernmental Group of Experts at its seventh session (TD/B/COM.2/CLP/57).**

Accordingly, the present document contains a revised version of the Directory of Competition Authorities, which can be used to facilitate contacts between officials whose duties include the control of restrictive business practices.
