# Item 1 Adoption of the agenda and organization of the work of the session

### Agenda

The provisional agenda for the session, as circulated to the Bureau of the Trade and Development Board on 23 January 1996, is reproduced in Section I above.

# Organization of work

The organization of work of the session, approved by the Bureau of the Board on 23 January 1996, is annexed hereto. Under rule 61 of its rules of procedure the Board may establish a Committee of the Whole to deal with the substantive preparations for the ninth session of the Conference. In this regard, the opening plenary meeting, on 26 February 1996, will be concerned essentially with item 2. The remainder of the items will be taken up at the final plenary meeting on 29 March 1996.

# Item 2 Preparatory process for the ninth session of the Conference

## Establishment of the Committee of the Whole

In accordance with a decision taken by the Trade and Development Board at its eighteenth special session, the Board will launch the preparatory process for the ninth session of the Conference by establishing an open-ended Committee of the Whole, to meet under the chairmanship of the President of the Board.

# Mandate of the Committee of the Whole

The Committee of the Whole will be entrusted with elaborating the substantive pre-Conference text for transmittal to the Conference, taking into account:

- Item 8 of the provisional agenda for the ninth session of the Conference, together with the agreed annotations to that item and the annexed background note by the UNCTAD secretariat;
- The Report of the Secretary-General of UNCTAD to the ninth session of the Conference;
- The reports of the Regional Ministerial Meetings and other regional and national contributions, including the outcome of topical seminars;

- General Assembly resolution A/50/103, of 20 December 1995, which calls upon the Conference to take into account the outcome of the High-Level Intergovernmental Meeting on the Mid-Term Global Review on the Implementation of the Programme of Action for the Least Developed Countries for the 1990s;
- Board decision 433 (S-XVIII), of 15 December 1995, on the review of recommendations of subsidiary bodies on their future work programmes, as well as on some institutional follow-up, particularly in relation to the substantive contents of the pre-Conference text;
- Recommendations 431 (S-XVIII), adopted by the Board on 15 December 1995, with regard to the final design of the intergovernmental machinery of UNCTAD, including the number, names and mandates of individual bodies to be determined in the light of the decisions taken on the substantive contents of the pre-Conference text.

The Committee of the Whole will also consider any other relevant matters which it deems necessary to be addressed as part of the preparatory process for the Conference.

At its closing plenary meeting, on 29 March 1996, the Board will consider and take action on the outcome of the Committee of the Whole.

### Timetable for the Committee of the Whole

A proposed schedule of meetings of the Committee of the Whole is annexed to the present document. The Board may wish to decide that the time-table should be considered as flexible, and subject to adjustment by the Committee in the light of developments.

### Item 5 Other business

#### Participation of experts in UNCTAD intergovernmental meetings

In its decision 432 (S-XVIII), of 15 December 1995, the Board requested the President of the Trade and Development Board to initiate informal consultations, in the context of the substantive preparatory process for UNCTAD IX, on the question of the participation of experts in UNCTAD intergovernmental meetings and requested the UNCTAD secretariat to update its note "Financial implications of providing travel assistance from the regular budget to experts from developing countries, notably LDCs" (TD/B/EX(7)/L.1). The Board further requested statistical information on the participation, including financing, of experts in UNCTAD meetings post-Cartagena.

At its meeting on 23 January 1996, the Bureau of the Board designated Mr. Javier Paulinich (Peru) to conduct, on behalf of the President of the Board, the informal consultations called for in Board decision 432 (S-XVIII), and to report on the outcome of his consultations to the twelfth executive session of the Board.

### Item 6 Report of the twelfth executive session of the Board

The draft report on the proceedings of the opening plenary meeting of the session will be before the Board at its closing meeting on 29 March 1996.
