Closure: Feasibility and Opportunity of the Hague Tourism Project

**The Hague Tourism Project** - The Project concerning a possible future Convention on Cooperation and Access to Justice for International Tourists originates from a proposal of the Government of Brazil, under the expertise of ASADIP. The Council on General Affair and Policy decided in 2015 that the Permanent Bureau should conduct a study on the Project.

The importance of tourism for the global economy, the growth of mass tourism and the increased participation of developing countries in tourism have brought issues concerning legal protection of those international tourists.

Language barriers, lack of knowledge of rights and remedies, inability to use mediation-conciliation beyond the stay in the visited country, inability to initiate (and continue) court proceedings beyond the stay in the visited country, absence of governmental authorities in charge of helping tourists, are examples of obstacles that international tourists might face regarding access to justice.

To tackle these issues, using the Hague Conference expertise in building global networks, The Brazilian Proposal suggests developing methods at a global level addressing these difficulties by setting up an international cooperation mechanism between Central Authorities together with provisions on access to justice. Such mechanisms will offer the international tourist the possibility of understanding the complaint in his own language. At the same time, any mediation attempt is made through the Authorities. The cooperation mechanism would also be of use if the mediation attempt fails. Therefore, international tourists would build on the Hague Conference's vast experience in building networks of Central Authorities in the field of international civil procedure to achieve rapid and facilitated protection of their rights.

#### **BRASILCON – BRAZILIAN INSTITUTE OF CONSUMER POLICY AND LAW**

The Brazilian Institute of Consumer Policy and Law (BRASILCON) is a national, multidisciplinary, non-profit association created in 1992 as an auxiliary entity in the consolidation of Consumer Law in Brazil. Updating and debating topics such as sustainability, responsible credit, collective consumer advocacy, quality of public services, international consumer protection, among others. Its founders are authors of the draft law that gave rise to the Brazilian Consumer Defense Code (Law 8.078 /90). The institute has national and international congresses of consumer rights, bringing together national and international interests, an international cycle of learning through the exchange of entities, professionals and academics in addition to bimonthly publication of the Journal of Consumer Law (RDC Thomson Reuters).
