## Voluntary peer review of competition law and policy: Uruguay

The purpose of a voluntary peer review of competition law and policy is to assess the legal framework and enforcement experience in a country and to draw lessons from past experiences, with a view to improving competition law enforcement in the country.

Uruguay has implemented considerable reforms in its competition law regime in the past decade. In this context, the Commission for the Promotion and Defence of Competition of Uruguay volunteered to participate in a peer review of competition law and policy organized by UNCTAD.

With substantial support provided by the Commission for the Promotion and Defence of Competition, the competition expert, Ms. Pamela Sittenfeld, assessed the state of competition law and policy in Uruguay and prepared a peer review report (*Voluntary Peer Review of Competition Law and Policy: Uruguay* (TD/B/C.I/CLP/41)).

This report will serve as the basis for the peer review examination to be conducted during the fifteenth session of the Intergovernmental Group of Experts on Competition Law and Policy. The examination panel will include representatives of the competition authorities of Mexico, Peru and Spain. In addition, speakers will be invited to contribute to the discussions. The peer review will be interactive, and will provide the competition authority of Uruguay with a unique opportunity to draw lessons from the experiences of other competition authorities in the implementation of competition law and policy.

The findings and policy recommendations of the peer review will be used to design tailor-made technical assistance activities to reinforce the effectiveness of competition law enforcement in Uruguay. Development agencies, technical assistance providers, bilateral donors and international organizations are invited to support the respective technical assistance activities.
