

- INFORMATION FOR PARTICIPANTS -

Regional Meeting on Promoting Services Sector Development and Trade-Led Growth in Africa

(Addis Ababa, Ethiopia, 12-13 September 2013)

The meeting is organized by UNCTAD in collaboration with the African Union Commission (AUC) and the United Nations Economic Commission for Africa (UNECA). The meeting is related *inter alia* to assistance that UNCTAD has extended to African countries to undertake Services Policy Reviews (SPRs). The meeting will be conducted in English and French, and simultaneous interpretation will be available.

1. Objective and expected outcomes of the meeting

The meeting aims to bring together stakeholders from different countries and regions within Africa and various development partners and donors to: i) disseminate the African SPR reports and discuss their findings, ii) exchange views on the topic of promoting services sector development and trade-led growth, and iii) identify elements of an African agenda relating to services policy-making and services trade negotiations.

It is expected that participants will be equipped with updated knowledge and better understanding on the multiple economic, social, development and trade implications of their policies and regulations on the services sector. Such knowledge and understanding would assist them in putting in place the adequate procedures and institutions that will allow them to successfully balance the needs and interests of all stakeholders, including government,

investors, operators, civil society and consumers. Also, the meeting will identify elements of an African agenda relating to services policy-making and services. Furthermore, participants will have an expanded network of professional contacts, which will be useful in their work and efforts to promote services sector development and trade-led growth in their countries.

2. Programme and schedule

The registration for the meeting starts at **08:30**, **12 September 2013** at **Conference Room 2**, and the Opening Session at 09:00. A provisional work programme is attached.

Lunch will be served during the meeting. Coffee and tea will be served during the breaks.

The meeting will be held in Conference Room 2, which is located on the first floor of the United Nations Conference Centre (UNCC) in the United Nations Economic Commission for Africa on Thursday, 12 September and Friday, 13 September 2013.

Immunization for yellow fever is also recommended prior to travel. Please bring a valid certificate of vaccination when you travel to Ethiopia.

5. Arrival in Addis Ababa

All participants should plan to arrive in Addis Ababa on the day prior to the event.

Addis Ababa Bole International Airport is located in the Bole district of Addis Ababa, five kilometers from the city centre.

Public transport and taxi: Participants may take one of the cream-coloured National Tour Operator taxis or the yellow airport taxi to their hotel. Arrangements for a paid shuttle service may also be made through the hotel.

From the airport, it takes approximately 30 minutes to reach the recommended hotels around the Convention Centre area. Normal fares can range up to 300 Ethiopia Birr or 20 US Dollar maximum. In general, the price of taxi fare is not fixed and is subject to negotiations.

Banking and currency exchange: A bank and bureau de change desk is available at Addis Ababa Bole International Airport.

The official currency of Ethiopia is the Ethiopian Birr. The exchange rate is approximately:

1 US Dollar (USD) = 18.33 Ethiopian Birr (ETB)



1 Euro (EUR) = 23.99 Ethiopian Birr (ETB)

(Please note that Ethiopian currency is not convertible to other currencies outside of the country.)

7. Climate

There are two seasons: - The dry season (Bega) from October through May and the wet season ("Kiremt") from June to September. The highest temperature is $25~^{\circ}c$ and lowest 9.7 °c. The annual average rainfall is 164.6~mm. Addis Ababa is a moderately mild and temperate city with an altitude of about 2400m or 8000ft above sea level. For September the average high temperature is $21~^{\circ}c$ and low is $11~^{\circ}c$.

GMT/UTC + 3 hours.

9. Electricity

Cities in Ethiopia including Addis use 220 volts 50 cycles Ac.

10. Credit cards

Major credit cards (VISA, AMERICAN EXPRESS, MASTERCARD) are accepted in some

restaurants and hotels (Sheraton, Hilton, Ghion, Axum...).

11. Travel arrangements and the daily subsistence allowance (DSA) for participants funded by UNCTAD

UNCTAD will directly contact the participants for completing required administrative arrangements, make flight reservations and send them electronic tickets. Accordingly, they should not purchase their own tickets.

It should be noted that once the ticket is issued, UNCTAD is not responsible for any modification of the reservation, nor is it liable for any additional financial cost that may be incurred by such modification.

The DSA rate in Addis Ababa is approximately 185 USD per day. It will be provided to the participants on the first day of the meeting.

For the disbursement of the DSA, participants funded by UNCTAD are kindly requested to bring along their air ticket (original), boarding pass stubs and passport (with entry visa) on the first day of the meeting. The DSA cannot be paid without these documents.
