#### Item 1

#### Election of officers

1. Under rule 64, paragraph 3, of the rules of procedure of the Trade and Development Board, and in accordance with the cycle of rotation for the election of the Chair and the Vice-Chair-cum-Rapporteur, the Chair of the Working Party at its sixty-fifth session will be a representative of list D. The Vice-Chair-cum-Rapporteur will be a representative of one of the States members on list A (Africa).

2. The Working Party will be invited to approve the provisional agenda for its sixtyfifth session, as reproduced in chapter I above.

#### Item 3

#### Review of the technical cooperation activities of UNCTAD and their financing

3. For its consideration of this item, the Working Party will have before it the report of the Secretary-General of UNCTAD entitled "Review of the technical cooperation activities of UNCTAD and their financing" (TD/B/WP/253), which deals with activities undertaken in 2012. This report is being submitted both to the Working Party at its sixty-fifth session and to the Trade and Development Board at its sixtieth session. The report contains analytical information on the different sources of financing for the technical cooperation activities of UNCTAD, i.e. voluntary contributions and their allocation by thematic areas and by regions or countries, as well as an updated overview of the structure and main features of UNCTAD technical cooperation activities was circulated to member States in March 2013 (UNCTAD/OSG/MISC/2013/1), and will be circulated as a non-paper document for discussion by the Working Party.

4. Annex I to the above-mentioned report, which is entitled "Review of activities undertaken in 2012" (TD/B/WP/253/Add.1), provides a review of the technical cooperation activities undertaken in 2012 under various programmes and projects. It contains background information on the activities, as well as information on their impact and results.

5. Annex II to the above-mentioned report, which is entitled "Statistical tables" (TD/B/WP/253/Add.2), provides data on financial contributions, project expenditures and the distribution of activities among different regions and programmes. It also provides a list of the projects under implementation in 2012.

6. Under this agenda item, and in accordance with paragraph 220 of the Accra Accord and paragraph 7 of Trade and Development Board decision 495 (LV), beneficiaries, donors and the secretariat will also have an opportunity to interact and consult on all issues regarding UNCTAD technical cooperation activities.

#### Item 4 Evaluation of UNCTAD activities

#### (a) Evaluation of UNCTAD activities: Overview

7. For its consideration of this item, the Working Party will have before it the report of the Secretary-General of UNCTAD entitled "Evaluation of UNCTAD activities: Overview" (TD/B/WP/254), which presents evaluation findings from 2012. The report contains descriptions of completed, ongoing and future evaluations, which can be helpful in informing the assessments, design and future implementation of UNCTAD projects and programmes. The Working Party will also be invited to review a proposal for the next iteration of the evaluation plan and to submit its conclusions and recommendations to the Trade and Development Board.

#### (b) External evaluation of UNCTAD subprogramme 1: Globalization, interdependence and development

8. In the context of its consideration of an annual external evaluation of an UNCTAD programme, the Trade and Development Board, at its fifty-sixth executive session, requested the UNCTAD secretariat to conduct an independent evaluation of the UNCTAD subprogramme on globalization, interdependence and development. The Board agreed that its subsidiary organ, the Working Party on the Strategic Framework and the Programme Budget, would consider the results of the evaluation at its sixty-fifth session, under the agenda item on evaluation. The evaluation report will be prepared by an independent evaluation team composed of a professional evaluator and two other team members who are familiar with UNCTAD programmes and who are regularly involved in the work of UNCTAD intergovernmental bodies (TD/B/WP/252, TD/B/WP(65)/CRP.1).

#### (c) Follow-up on evaluations:

# (i) Follow-up on recommendations from the evaluation of UNCTAD's programme on science and technology for development

9. At its sixty-second session, the Working Party requested that member States further discuss the recommendations contained in the evaluation report of the UNCTAD programme on science and technology for development (TD/B/WP/234, TD/B/WP(59)/CRP.1) and decided that such discussions would take place before the next session of the Working Party on technical cooperation.

# (ii) Third progress report on the implementation of recommendations from the evaluation of UNCTAD's technical cooperation activities dedicated to least developed countries, landlocked developing countries, small island developing States and other structurally weak, vulnerable and small economies

10. At its sixty-second session, the Working Party also requested the secretariat to report back on further progress made in the implementation of the recommendations from the independent external evaluation of UNCTAD's technical cooperation activities dedicated to least developed countries, landlocked developing countries, small island developing States and other structurally weak, vulnerable and small economies (TD/B/WP/223, TD/B/WP/223/Add.1, TD/B/WP(56)/CRP.1). The secretariat will provide an update on the progress made in implementing those recommendations.
