


## The IDI is.....

# Capacity building in Public Debt Audit by INTOSAI

- INTOSAI has a Working Group on Public Debt (WGPD)
  - Chaired by SAI Mexico
  - Consists of 17 member SAIs and 5 observer SAIs
  - Has produced 7 guidance documents.
  - IDI is observer at WGPD meetings

# Capacity building in Public Debt Audit by the IDI

- The IDI has worked in cooperation with INTOSAI WGPD to deliver training and other broader capacity building programmes for developing SAIs in INTOSAI regions

- Target SAIs : 23 English speaking and 8 French Speaking SAIs


