Summary of meetings Friday, 16 September 2011

Sessional Committee I - First plenary meeting

Item 5 Implementation of the outcome from LDC-IV: UNCTAD's contribution

Mr. Supachai Panitchpakdi, Secretary-General of UNCTAD, made an opening statement. This was followed by a statement by Mr. Cheick Sidi Diarra, Under-Secretary-General and High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States, and an introductory statement on agenda item 5 by Mr. Charles Gore, Head, Research and Policy Analysis Branch, Division for Africa, Least Developed Countries and Special Programmes, UNCTAD.

General statements

Statements were made by representatives of the following member States: Nepal (on behalf of the Least Developed Countries), Turkey, Zimbabwe (on behalf of the Group of 77 and China), Ghana (on behalf of the African Group), the Dominican Republic (on behalf of the Group of Latin American and Caribbean Countries), Thailand (on behalf of the Asian Group), Paraguay (on behalf of the Landlocked Developing Countries), China, Cambodia.

Item 9 Investment for development: Implications of non-equity forms of transnational corporations' operations

Mr. Supachai Panitchpakdi, Secretary-General of UNCTAD, made an opening statement. This was followed by a presentation of the *World Investment Report* by Mr. James Zhan, Director, Division on Investment and Enterprise.

Mr. Mark Casson, Professor of International Business, University of Reading, United Kingdom, acted as a discussant during the interactive debate.

An interactive debate followed with interventions by the representatives of Zimbabwe, the Philippines (on behalf of the Asian Group), Paraguay (on behalf of the Landlocked Developing Countries), Chile (on behalf of the Group of Latin American and Caribbean Countries), Ghana (on behalf of the African Group), Hungary (on behalf of Group D).

The panellists made concluding remarks.
