Investment Policy Review Day

UNCTAD will hold a one-day high-level dialogue dedicated to the presentation and discussion of the Investment Policy Reviews of Bosnia and Herzegovina and Madagascar. The event will take place on Thursday, 3 December 2015. The morning session (10 a.m. to 1 p.m.) will be devoted to the Investment Policy Review of Bosnia and Herzegovina, and the afternoon session (3 p.m. to 6 p.m.) to the Investment Policy Review of Madagascar. Both sessions will be attended by ministers and high-level private sector representatives.

The programme will feature policy statements by high-level government officials as well as presentations of the two Investment Policy Reviews by the UNCTAD secretariat. Delegations and representatives of the private sector will be invited to comment on the reports, which will be subject to a general and open discussion. The event will take place in Room XXVI of the Palais des Nations in Geneva. Simultaneous interpretation will be provided in the six official languages of the United Nations.
