Existing Support Programs

Subsidies by the Agency of Interventions and Payments for Agriculture (AIPA). 2018 total budget MDL900 mln (EUR45 mln):

- Investment in agricultural holdings for restructuring and adaptation to EU standards
- Investments in the processing and marketing of agricultural products
- Trainings for the implementation of the actions related to the environment and the rural space
- Improvement and development of rural infrastructure
- Consultancy and training services

Moldova Agriculture Competitiveness Project by the World Bank (2012-2019)

- Enhancing food safety management USD 11.8 mln
- Enhancing market access potential USD 38.34 mln
- Enhancing land productivity through sustainable land management USD 9 mln
- Project management USD2.6 mln
- Compensatory sales support grants USD6.8 mln













Existing Support Programs

Rural Economic & Climate Resilience Programme (IFAD VI): 2014 – 2020. Budget USD16 mln (loans) + USD10 mln (grants)

Component I: Climate change resilience and inclusive value chain development

Component II: Inclusive rural financing and capacity development

Component III: Development of economic infrastructure for rural resilience and growth

Institutional support within organic farming in the Republic of Moldova: 2017-2021. Budget 15.900.000CZK (EUR650.000)

Expected results:

-Reinforced institutional structure in the field of organic farming

- -Operational system for unified approval of inputs to organic farming
- -Strengthened competency of local laboratory in the field of organic farming
- -Established system for recommendation of organic agro-technological procedures, species and varieties
