# WSIS Overall Review: Background

- The World Summit on the Information Society (WSIS) Outcome Documents and the **UN General Assembly Resolution 60/252** resolved to conduct an overall review of the implementation of the Summit outcomes in 2015.
- The modalities for the Overall Review were discussed at the 68th Session of the UN General Assembly. **Modalities were expected to be finalized by end of March 2014.**
- Following the guidance of its Membership (**PP-10 Resolution 172**) ITU initiated coordination process at the UNCEB level leading towards the open consultations on the Overall Review under UNGIS umbrella.



# WSIS Overall Review: Background

- **UNGIS Open Consultation** provided input to WSIS Forum 2012 where consensus was developed on the **Action Plan for WSIS+10 Review**, consisting of series of events including
  - **First WSIS+10 Review Meeting**, which was hosted by UNESCO, co-organized by UNESCO, ITU, UNCTAD, UNDP and was held in Paris in February 2013
  - **WSIS Forum 2013**, and its WSIS+10 Visioning Challenge, which were held in May 2013
  - **ITU coordinated WSIS+10 High Level Event**, which initially was scheduled to be held in April 2014



# WSIS Overall Review: Background

- **Government of Egypt** proposed to host the ITU Coordinated WSIS+10 High-Level Event in Sharm el-Sheikh, in April 2014, which was welcomed by CSTD and later on by ECOSOC in its resolution E/RES/2013/9.



**ITU Council Resolution 1334 (Mod. 2013)** agreed on the format of the event, expected the outcomes, preparatory process and modalities for event. All UN agencies mandated to facilitate implementation of the Geneva Plan of Action agreed to be co-coordinators.

- **Preparatory Process as WSIS+10** Multistakeholder Preparatory Platform started in July 2013 and consists of Six Phases.
- In February 2014 it was decided that the ITU coordinated WSIS+10 High Level Event will be held from **9-13 June 2014 in Geneva**



# Council Resolution 1334 (MOD. 2013)

## WSIS+10 High Level Event

**The WSIS+10 High-Level Event will be an Extended Version of the WSIS Forum**

### WSIS+10 High Level Track

- address the progress made in the implementation of the WSIS outcomes related to the WSIS Action Lines under mandates of the participating agencies

### WSIS Forum Track

- provide a platform for multi-stakeholder coordination of the implementation of the WSIS outcomes, with involvement and participation of all WSIS action line facilitators, other UN agencies and all WSIS stakeholders.

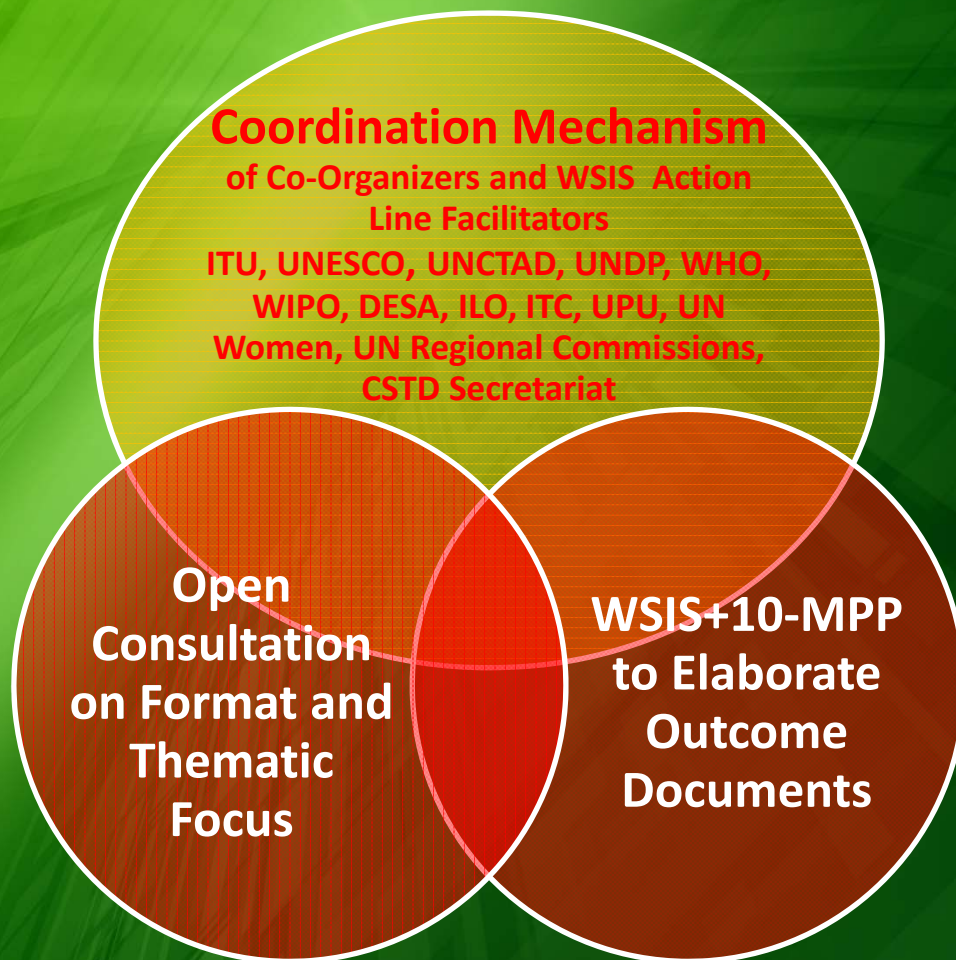

# Preparatory Process

## Link between WSIS and Post 2015 Development Agenda

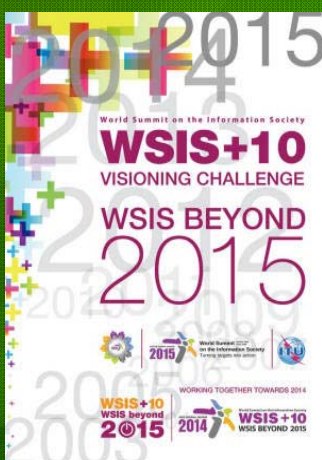

# WSIS+10 MPP Principles for Developing the Outcome Documents: Statement and Vision

- Focus on the WSIS Action Lines and measurement of their implementation.
- Develop a vision upon existing framework of Action Lines, identifying emerging trends, challenges and priorities for new decade, without making existing framework of Action Lines obsolete.
- Geneva Declaration and Geneva Plan of Action still remain valid until further decisions by General Assembly.
- Restrict the proposals on Action Lines, under the responsibility of the respective UN Agencies, to the Geneva Plan of Action.
- Avoid proposals referring to the outcomes of the Tunis phase of WSIS on the following, implementation mechanism, follow up, internet governance (other than internet issues relevant to action lines), IGF, enhanced cooperation, CSTD.
- Avoid prejudging the outcomes of the 68th Session of the General Assembly on modalities of the Overall Review.
- Respect mandates given by Tunis Agenda and respect for the multi-stakeholder principles.



# WSIS+10: Preparatory Process

## First Physical Meeting: 7-8 October 2013

- **All WSIS Action Line Facilitators and other UN agencies:**

### Policy Statements

**W**orld Summit on the Information Society +10 (WSIS+10) High-Level Event will be held in ITU Headquarters, Geneva, 10-13 June 2014. A series of pre-event meetings will also be held on 9 June 2014. The WSIS+10 High-Level Event will be an extended version of the WSIS Forum and is expected to endorse the "WSIS+10 Statement on Implementation of WSIS Outcomes" and the "WSIS+10 Vision for WSIS Beyond 2015". These Outcome Documents are, at present, being developed in an open and inclusive preparatory process (WSIS+10 MPP).

The Event will build upon two tracks, the *High-Level Track*, consisting of formal statements, handing over of prizes, and endorsement of the Outcome Documents, and the *Forum Track*. Building upon the tradition of annual WSIS Forum May meetings, the Forum track's format and thematic focus are the result of an open consultation process with the involvement of all WSIS Stakeholders. This will offer participants a series of high-level panels, a ministerial round table, action line facilitation meetings, country workshops, thematic workshops and knowledge exchanges, as well as an exhibition. The Forum track will address issues that are critical to WSIS implementation and follow-up in multi-stakeholder settings. It will include discussions on implementation of WSIS related activities beyond 2015.

The High-Level Track (HLT) will be held on 10th and 11th June 2014 and will provide a special platform for high-ranking officials of WSIS Stakeholders, Government, Private Sector, Civil Society and International Organization to express their views on the achievements, challenges and recommendations on the implementation of WSIS Action Lines, emerging trends and matters of strategic importance to the development of the telecommunication and information and communication technology sector. In addition four High-Level Dialogues will be held on 12th June 2014.

- Partnership on Measuring ICT for Development developed a set of indicators to measure the **WSIS targets**
- Final assessment of progress made towards each of the ten WSIS targets
  - Major report coordinated by ITU and involving many contributors
  - The only *quantitative* global assessment of WSIS outcomes
  - Based on data collection carried out in 2013 with all member states (WSIS targets questionnaire)
- Launch of final report: **WSIS+10 High-level Event, 10-13 June 2014, Geneva**

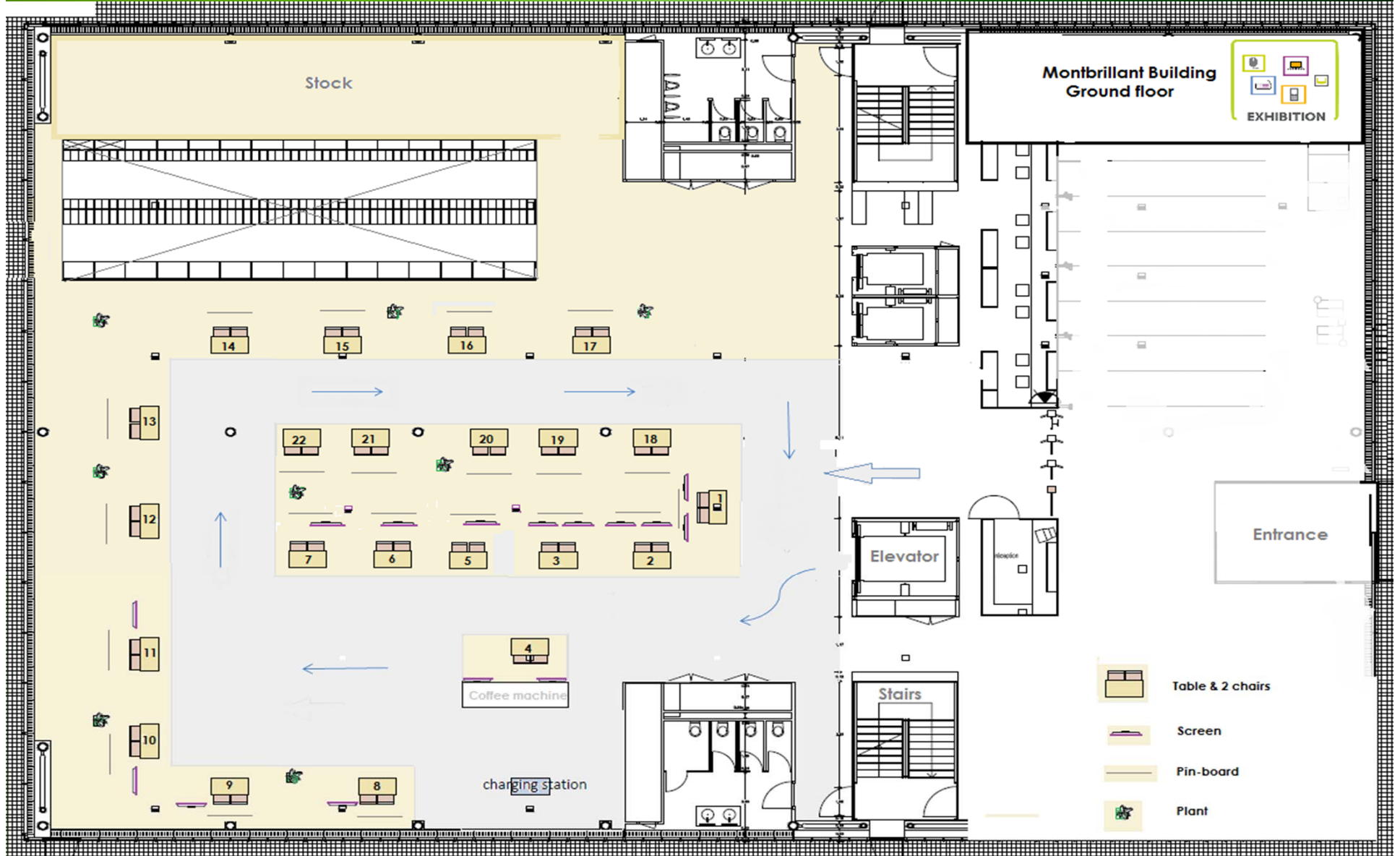

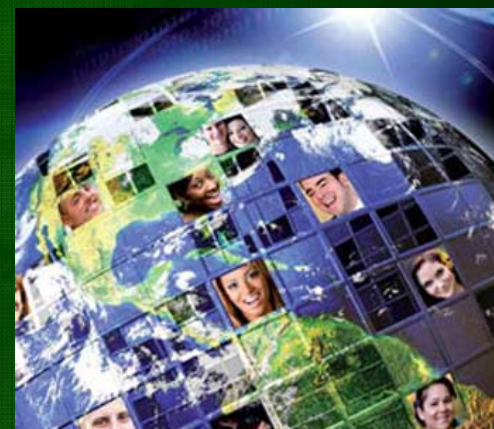
