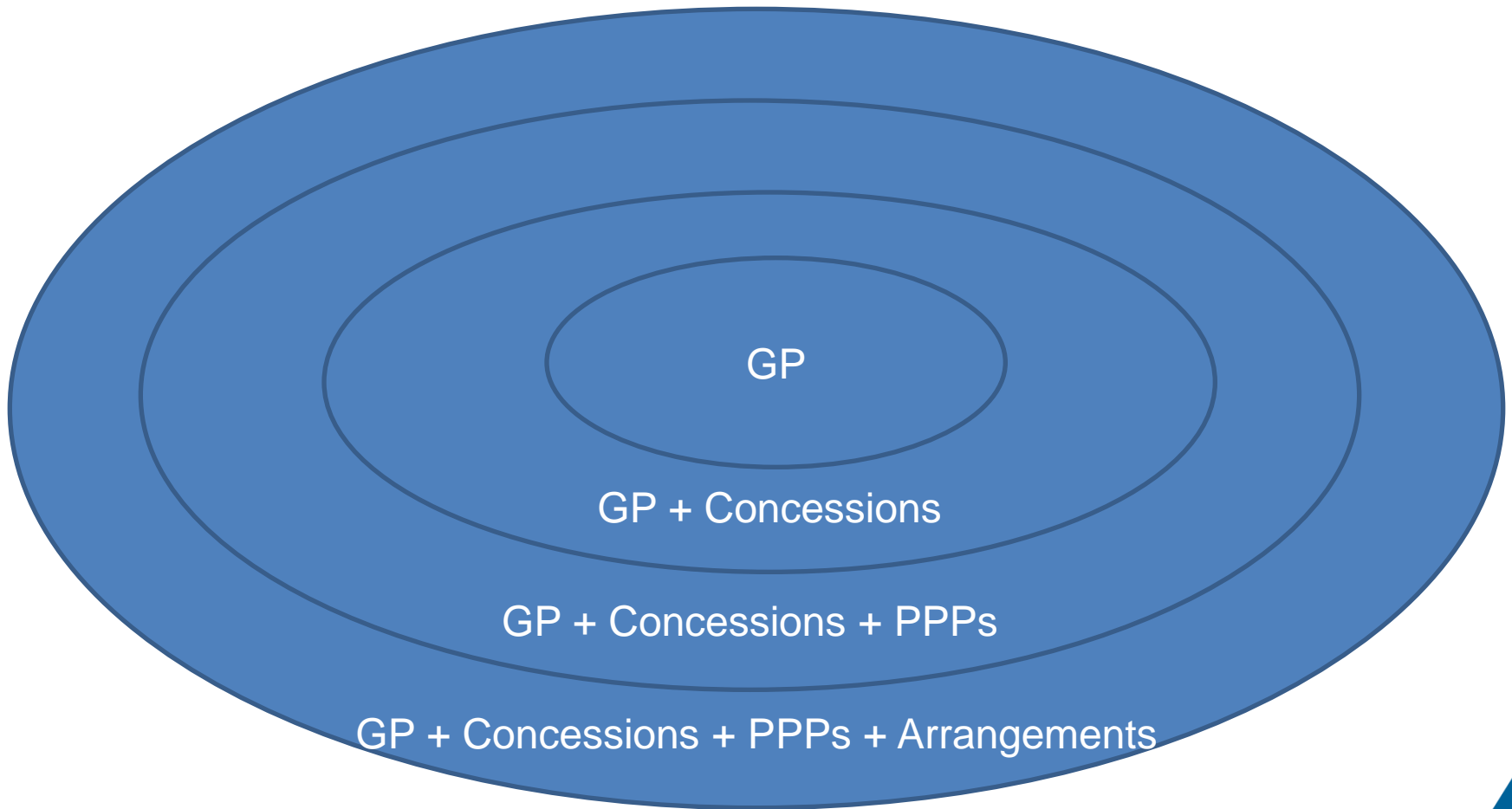


Objectives

- MAST is not about legitimacy or discrimination
- Chapter M : Government Procurement Restrictions
- *“Collect measures controlling the purchase of goods by government agency, generally by preferring national providers”*:
 - Government Regulations: when it clearly state a preference for national providers
 - Administrative Procedures: when it will give preference (intentionally or not) to national providers plus it informs on exemptions and applications of law

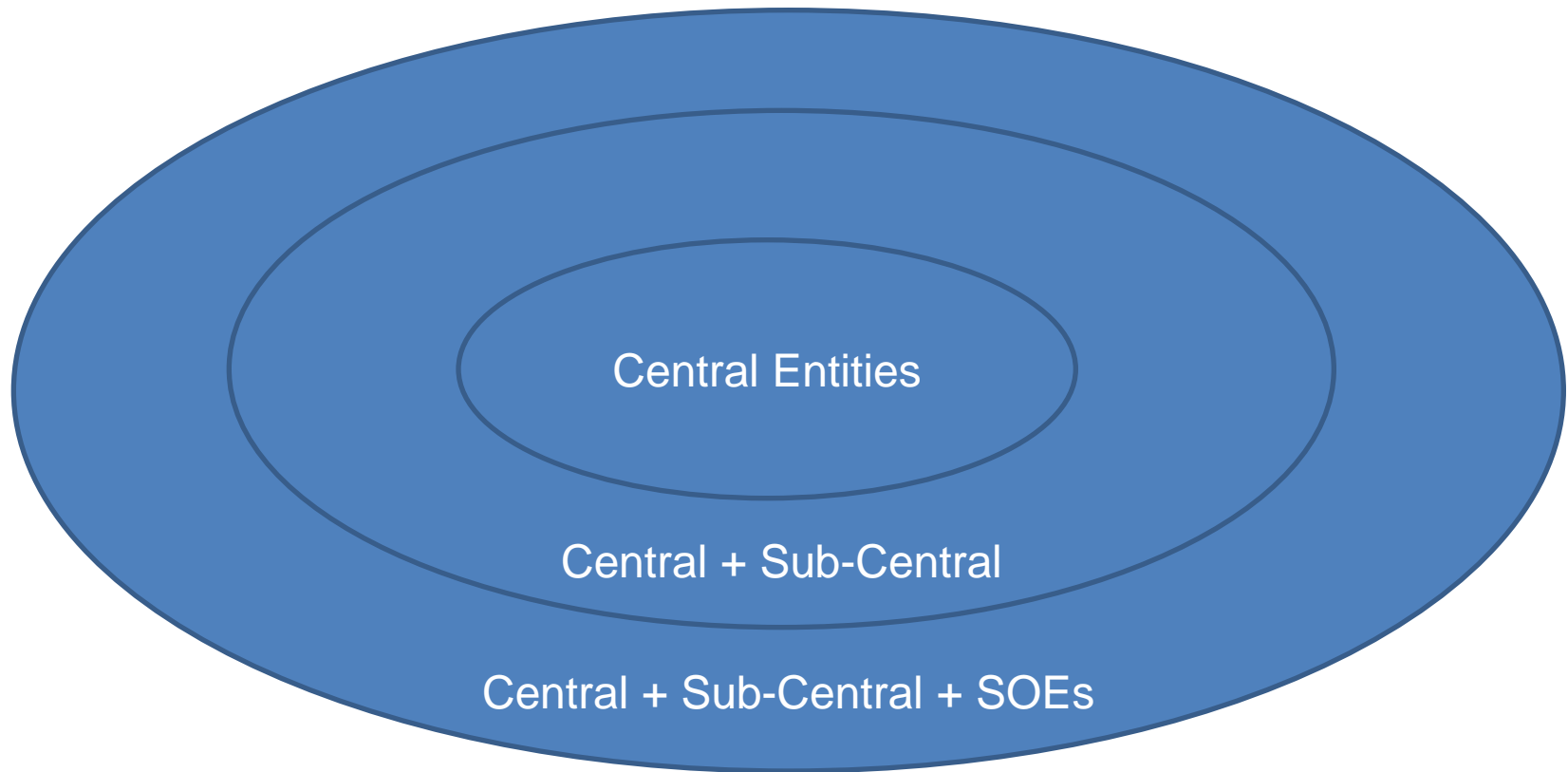

Challenge 3: Level of Aggregation

- For Government regulation: “Easy”
 - Sectors are mentioned in laws : find HS codes (as in Global Trade Alert)
- For Administrative procedures: More challenging
 - Does procedure change across sectors?
 - If change for same sector: average by sector?
 - What product/sector in other dataset on GP?



Challenge 3: Level of Aggregation

- For instance in WTO-GPA datasets
 - For legislation or threshold documentation: broad sectors as goods, construction, services
 - For statistics on contracts: there are categories at 2 digits for goods and services: which classification?
- In Contract award data, example with TED (EC)
 - Classification by activity of contracting authority (COFOG) : General public service, Health; Defense; Education etc...
 - “CPV code”: equivalent to HS code with more than 10,000 goods and services



Challenge 4: Data Sources

- Government Regulations:
 - Legislation on Public Procurement: already some collected by WTO for GPA
 - Other?
- Administrative Procedures:
 - If differs for each contract award ... pain!
 - Where to find such info?
 - Follow steps of official procedure to detect where barriers can appear

OECD existing work on GP

- **Transparency Procurement Indicators: A sub-section on Openness**
 - Promoting competition: procurement procedure
 - Promoting competition: number of bids and number of international bidders
 - Transparency of public procurement information

- **STRI index : A sub-section on restrictions in GP for services (1 procurement law and 2 procurement procedures)**
 - Explicit preferences for local supplier
 - Technical specifications affect the conditions of competition in favor of local
 - Contract award on the basis of non-objective/discriminatory criteria



To conclude

- Challenges 1 and 2 could be objectively addressed during our discussion
- There are massive problems with challenges 3 and 4, in particular for the administrative procedures component
- Other challenges exist that we have missed in this presentation
- The proposals of taxonomy exposed here were just illustration of what is a final output for such work
