

Government Procurement System in the Russian Federation

Reform of Government Procurement (GP) System



In 2011 the FAS Russia examined 37 770 complaints filed by the suppliers (out of the total amount 42% considered fully valid). In 2011 the FAS Russia won 86 % of cases in courts (out of the total quantity of appealed cases)

Major achievements of present Government Procurement System


1. The hit rate (by the internet users) to the official GP portal - **more than 8 million a day**

2. Number of accredited companies at electronic trading platforms- more than 200 thousand

3. Number of issued electronic digital signatures to suppliers and procurement entities **more than 1 million**


4. Number of procurement entities on the official GP portal - 209,5 thousand

5. Aggregated economic effect (total budget funds saving) for the mere 6 years(2006-2011) more than **1 448 billion Rubles (more than 36 billion Euro)** – these are new possibilities for acquisition of necessary goods, as well as developing infrastructure

Proposed solution to the major issues of Government Procurement

 \checkmark detailed regulation of all stages of procurement placement: from planning and placement to contract fulfillment and analysis of the acquired results.

 \checkmark centralization of public procurement – public procurement placement mainly through authorized representative units: substitution of 209,5 thousand single procurement entities by 2-3 thousand authorized procurement centers.

✓ detailed procedure of explanation of setting starting (maximum) price of the contract

 \checkmark fast track procedure of contract termination through the FAS Russia in case of wrong-doing according to terms of contracts (within 10 days)

✓ centralized registers of financial guarantees

 \checkmark establishment of additional requirements (criteria) to the supplier on the basis of fulfillment of the previous contracts

 \checkmark organizing the register of improper suppliers not only according to the names of organizations but also including the names of the managers.

✓ establishment of the register of honest suppliers (suppliers which fulfilled contacts at good quality rate), such suppliers should provide less financial guarantees (2-3 times less)
