Mr. President,

The global community is engaged in a process of evaluating the performance of the MDGs and in crafting new objectives and goals for the post-2015 period. UNCTAD, as a UN think-tank with its mandate of treating trade, investment, finance, science and technology and development in an integrated manner, could play an important role in the post -2015 development agenda. We are confident, Mr. President, that under your able guidance UNCTAD would significantly enhance its contribution towards creating ambitious and achievable goals and targets.

Mr. President,

Mr. President,

The world economy is still struggling to recover from the worst recession since the Great Depression. Global economic growth in 2013 is likely to be even lower than the mere 2.2. The global unemployment rate is still high. As it is noted in the Trade and Development Report 2013 the current global economic and financial crisis reflects a structural shift of the world economy, and that adjusting to this structural change requires fundamental changes to the dominant growth strategies. The World Investment Report shows that the global FDI declined in 2012 and it indicates that the road to FDI recovery after the financial and economic crisis remains bumpy and uncertain. These are critical development challenges that all countries continue to face. There is no any country that could be able to address them alone. In a highly interdependent world, all countries should come together and seek a sustainable way out of this difficult post-economic and financial uncertainty.

UNCTAD and particularly the Trade and Development Board with its universal membership and as a UN-development think tank, is uniquely positioned to be a vital forum for all governments including the civil society and the academia to discuss and reach at a common understanding to the development challenges. UNCTAD`s independent research and policy analysis work could be a catalyst for consensus building among member states. The topics for this year TDB session could contribute for better understanding of the global development challenges. Our deliberations and their outcomes could shape the global development dialogue. The African Group is ready to constructively and actively engage in the sessions of the TDB with the objective of achieving common positions.
