[Arancha González, Executive Director, International Trade Center](#)

Arancha González, an expert in international trade issues with 20 years of experience, serves as Executive Director of the International Trade Centre (ITC), the joint development agency of the United Nations and the World Trade Organisation, since September 2013. Ms. González, a Spanish national, has extensive knowledge about international trade and economics, coupled with broad experience in trade and development matters in the public and private sectors, as well as in management at multilateral organizations. Before joining ITC, Ms. González served as Chief of Staff to World Trade Organization Director-General Pascal Lamy from 2005 to 2013. During her tenure at the WTO, she played an active role in launching the Aid for Trade initiative and served as Mr. Lamy's representative (Sherpa) at the G-20. Prior to working at the WTO, Ms. González held several positions at the European Commission, conducting negotiations of trade agreements and assisting developing countries in trade-development efforts. Between 2002 and 2004, she was the European Commission spokeswoman for trade and adviser to the European Union Trade Commissioner. Ms. González began her career in the private sector as an associate in a German law firm advising companies on trade, competition and state-aid matters. Ms. González holds a degree in law from the University of Navarra and a postgraduate degree in European Law from the University of Carlos III, Madrid. She co-chairs the World Economic Forum (WEF) Agenda Council on the Future of Trade and Investment. Besides her native Spanish, she speaks English, French, German and Italian.

Edwini Kessie has a Doctorate Degree in Law from the University of Technology, Sydney, Australia, and Master's Degrees in Law from the University of Toronto, Canada and the University of Brussels, Belgium, and a Bachelor's Degree in Law from the University of Ghana. He is admitted as a solicitor of the Supreme Court of England and Wales, New South Wales, Australia and Ghana. He has practiced Corporate and Commercial Law in Sydney, Australia and International Trade Law and European Community Law in Brussels, Belgium. Dr. Kessie has been a staff member of the World Trade Organization (WTO) since January 1995. He has worked in different Divisions, including the Council and Trade Negotiations Committee Division, Development Division and the Institute for Training and Technical Cooperation. He is currently the Director of the Agriculture and Commodities Division. Between June 2012 and May 2017, Dr. Kessie took leave from the WTO to become the Chief Trade Adviser of the Pacific Island Countries and Chief Executive Officer of the Office of the Chief Trade Adviser located in Port Vila, Vanuatu. In his capacity, he provided technical advice on a broad range of trade and investment issues to the Pacific Island countries and supported them in the free trade negotiations (PACER Plus) with Australia and New Zealand. Dr. Kessie has participated in many international conferences on international trade and written a number of articles on international trade issues. His principal areas of interest are regional integration, agriculture, trade and development and dispute settlement.

Session 2: Sustainable job creation in extractive industries

William Baah-Boateng, Associate Professor, Department of Economics, University of Ghana Legon

William Baah-Boateng holds PhD in economics and is an Associate Professor of Economics at the University of Ghana with particular research and teaching focus on economics of labour and labour market institutions, skills development, enterprise development and development economics. He is a senior fellow of the International Institute for Advanced Studies (IIAS) in Accra and an editor of the Ghanaian Journal of Economics. He studied at the University of Ghana and Harvard University in Massachusetts. He was an Ela Bhatt visiting professor at the ICDD of University of Kassel in Germany in 2015/16 and a Senior Research Fellowship at the Centre for African Studies (CAS), Harvard University. William was appointed by the President of Ghana to serve on the Presidential Committee on Emoluments to determine the salaries and service conditions of the three arms of government (the executive, legislature and the judiciary) and other constitutionally created institutions.

Tony Addison, Chief Economist, UNU-WIDE

Tony Addison is the Chief Economist/Deputy Director of the United Nations University's World Institute for Development Economics Research (UNU-WIDER) in Helsinki, Finland. He was previously Professor of Development Studies and Executive Director of the Brooks World Poverty Institute, Manchester University. He has worked extensively on economic policy with governments as well as bilateral and multilateral agencies. He has published widely in books and journals on issues of development finance, debt relief, fiscal policy, poverty dynamics, and post-conflict reconstruction. His latest book is Extractive Industries: The Management of Resources as a Driver of Sustainable Development (Oxford University Press, Forthcoming September 2018).

Session 4: Energy transition, natural gas and the skill gap

Ashutosh Shastri, Director, EnerStat Consulting, United Kingdom

Ashutosh Shastri is the founder of EnerStrat Consulting- a London based international strategic management consultancy practice in the Energy Sector. Ashutosh has advised leading international energy companies in their corporate and business unit strategies, conducted due diligence for Private Equity and VC funds, provided analyses of macroeconomic and geo-political trends in global energy and its implications for Institutional Investors/Asset Managers. He has acted as independent expert in a range of commercial renegotiations/disputes in the natural gas/LNG and electricity contracts, and he is an adviser to the Commonwealth Secretariat. He also has experience of Track 2 international dialogues on Energy and Climate Negotiations and has provided expert testimony to various (UK) parliamentary committees on Shale Gas, LNG and Energy Security and Pricing. Between 2011 and 2013, he advised the UNECE Gas Centre in Geneva with special emphasis on Unconventional/Shale Gas-Global LNG and the expansion of its scope of activities to cover Asia Pacific Region. He has also acted as policy adviser to National Governments in Africa and elsewhere where his experience includes conducting policy framing workshops for senior government decision makers and crafting energy policies. He has authored several published papers on Global Unconventional/Shale Gas, LNG, Smart Grids and Wind Energy.

Rolf Traeger, Chief, LDC Section, Division for Africa, Least Developed Countries and Special Programmes, UNCTAD

Rolf Traeger he has been working since 1991 as an economist for the United Nations, mainly at the United Nations Conference on Trade and Development (UNCTAD). There, since 2014 he has been the Chief of the LDC Section and lead author of the organization's Least Developed Countries Report, which he has co-authored since 2007. Xunpeng (Roc) Shi, Australia-China Relations Institute, University of Technology of Sydney

Xunpeng (Roc) Shi is a Principal Research Fellow at the Australia-China Relations Institute, University of Technology Sydney. He is also China's Hubei 'Chutian' Scholar Visiting Professor at the Center of Hubei Cooperative Innovation for Emissions Trading System, Hubei University of Economics, and an Adjunct Senior Research Fellow at the Energy Studies Institute (ESI), National University of Singapore. He is currently serving as President of the Chinese Economics Society Australia (CESA) and an Associate Editor of Journal of Modelling in Management. His areas of expertise include the Chinese economy, and energy economics and policy, with a regional focus of ASEAN, and Northeast Asia. He graduated with PhD and Master degrees from the Australian National University, a LLM degree from University of Dundee (under British Chevening Scholarship), and a Bachelor degree from China University of Mining and Technology.

Alexandra Laurent, Statistician, Commodities Branch-DITC, UNCTAD

Alexandra Laurent joined the Special Unit on Commodities (SUC) of UNCTAD in 2001. For 10 years, she contributed to the development of Infocomm, an electronic portal on commodities – drafting 25 technical papers on individual commodity markets – and supported the implementation of Infoshare, a sharing database implemented in Cameroon, the Pacific islands and the Caribbean. In 2011, Mrs. Laurent was appointed as the statistician of the SUC. She is responsible for drafting two recurrent publications: (1) The State of Commodity Dependence - a biannual report that provides individual country profiles for 135 developing countries with regards to their commodity-dependence status. The third issue of this State of Commodity Dependence has been made available in October 2017. (2) The Commodities at a glance series is a publication - available in both English and French - that presents and disseminates topical information linked to specific commodity markets in a clear, concise and friendly format. Mrs Laurent is currently working on the preparation of the forthcoming issue dealing with the topical issue of the shale gas sector. Mrs. Laurent holds a Master degree in Management from SKEMA business school, Sophia Antipolis, France, and a Master of Arts in International Finance from the University of Westminster, London, United Kingdom.



Alvaro Ríos, Partner and Director, Gas Energy Latin America, Bolivia

Alvaro Ríos is currently the managing partner at Gas Energy Latin America. He leads studies and carries out energy consulting services throughout Latin America with focus in the natural gas chain, power and petrochemical sectors. He was the executive secretary of OLADE (2006-2007) and Ministry of Hydrocarbons of Bolivia (2003-2004). He graduated as a Chemical Engineer from Texas A&M University and later accomplished postgraduate studies in Chemical Engineer at University of Houston in Chemical Engineering. He successively headed the Legal and Commercial departments and was before taking up his current positions Commercial Director and responsible for Business Development & Strategy.

Session 5: Changing skill requirements in the mining sector

Nicky Black, Director of Environmental Stewardship and Social Progress, International Council on Mining and Metals (ICMM)

Nicky Black joined ICMM in June 2017 as director of Environmental Stewardship and Social Progress. She is responsible for providing strategic and operational leadership to ICMM's work in this area, including water use, climate change, closure planning, human rights, community relations, land stewardship and economic opportunities. Nicky has over 15 years experience working in sustainable development. Before joining ICMM, Nicky spent seven years with the De Beers Group of Companies in London. Her last role with De Beers was as the Head of Social Performance, with responsibility for the company's social management programme, sustainability reporting and communications, and working with the board and executive committee to set and align sustainability strategy. Nicky holds a PhD in Strategic Management from the University of Waikato in New Zealand, a Master's degree in Political Sociology from McGill University in Canada, and a degree in Human Sciences from the University of Oxford in the UK.

Isabelle Durant, Deputy Secretary-General, UNCTAD

Ms. Durant brings to the position a wealth of international experience at the senior level, in the political, diplomatic and development policy at the national, regional and global levels interacting with governments, the private sector and civil society. Ms. Durant is currently a member of the Parliament of Brussels-Capital Region. She was also member of the European Parliament Budget Committee in charge of Project bounds and financial transaction tax. She has experience in intergovernmental processes, representation, communication and mobilizing actions. From 2003 to 2006, she was an assistant professor at San Francisco State University, teaching and researching on macroeconomics, international economics and econometrics.
