### Item 3

#### Trade in services for inclusive and sustainable development

3. As a major contributor to output, jobs, investment and trade, services are key to economic and human development and hence to the achievement of the inclusive and Sustainable Development Goals of the 2030 Agenda for Sustainable Development, adopted by Member States of the United Nations. Trade in services has the potential to enhance this role, as its share in the world economy, according to the World Bank, has increased steadily – from 9.2 per cent in 2000 to 12.66 per cent in 2016.<sup>1</sup>

4. Member States of the United Nations will conduct a thematic review of progress on the 2030 Agenda for Sustainable Development at the high-level political forum on sustainable development to be held from 9 to 18 July 2018. The forum, whose theme is “Transformation towards sustainable and resilient societies”, will examine progress achieved in relation to specific goals, including Goals 6 (ensure availability and sustainable management of water and sanitation for all), 7 (ensure access to affordable, reliable, sustainable and modern energy for all), 12 (ensure sustainable consumption and production patterns) and 17 (strengthen the means of implementation and revitalize the Global Partnership for Sustainable Development).

5. The sixth session of the Expert Meeting, with a focus on trade in services dealing with water and sanitation, energy and food-related logistics, could usefully contribute to the aforementioned review. Experts will consider the dynamics of trade in these services and explore ways and means to facilitate and expand their trade with a view to achieving the relevant Sustainable Development Goals. In particular, the Expert Meeting will discuss market access and regulation in these services sectors, including trade liberalization under multilateral and regional trade agreements, and the prospective impact on these sectors of ongoing negotiations in the World Trade Organization. Best-fit practices and policy recommendations will be explored, including through the exchange of national and regional experiences.

6. To facilitate discussion, the UNCTAD secretariat has prepared a background note, TD/B/C.I/MEM.4/17. In addition, experts are encouraged to prepare case studies on the subject under discussion. These papers will be made available at the meeting in the form and language in which they are received.
