## II. Annotations to the provisional agenda

1. The ninth session of the Trade and Development Commission will be held from 27 November to 1 December 2017. The role of the Commission, as defined in paragraph 201 of the Accra Accord, is to conduct policy dialogue on one or two selected issues, consider reports of expert meetings, manage and recommend for approval the work programme of expert meetings within its purview, and promote and strengthen synergies among the three pillars.
2. The substantive agenda item of the ninth session of the Trade and Development Commission was approved on 5 April 2017, during the thirty-first special session of the Trade and Development Board. The substantive topic for the ninth session of the Trade and Development Commission is entitled "From decisions to actions: Trade as a catalyst for accomplishing the 2030 Agenda for Sustainable Development". In addition, the Commission will review and adopt the reports of expert meetings and intergovernmental groups of experts. Furthermore, the Commission will examine relevant activities implemented by the secretariat which have promoted and strengthened synergies among the three pillars.
3. As provided in paragraph 190 of the Accra Accord, the ninth session of the Commission should aim at producing outcomes that are more action-oriented and identify practical solutions to trade and development problems. As stipulated in paragraph 203 of the Accra Accord, the outcomes of the session will be agreed conclusions from the policy dialogue and recommendations to the secretariat achieved within the scheduled time of the session.

### Item 1

#### Election of officers

4. In accordance with rule 18 of the rules of procedure of the Main Committees of the Trade and Development Board, the Commission is to elect a Chair, five Vice-Chairs and a Rapporteur from among the representatives of its members, taking into account the need to ensure equitable geographical distribution. In accordance with rule 19 of the rules of procedure, the Bureau of the Commission shall consist of seven members: four members from lists A and C combined, two from list B and one from list D, referred to in the annex to General Assembly resolution 1995 (XIX) as amended.
5. Accordingly, following the cycle of rotation, the Bureau for the ninth session of the Commission will be as follows: a Chair from list B, a Rapporteur from list A (Asia), three Vice-Chairs from lists A and C combined, one Vice-Chair from list B and one Vice-Chair from list D.

6. The agenda was prepared in accordance with the Accra Accord and the Doha Mandate. A programme of work will be circulated prior to the meeting.
