SUMMARY OF MEETINGS Tuesday, 25 September 2012

1092nd plenary meeting

Item 7 Evolution of the international trading system and its trends from a development perspective

Key issues arising from the international trading system and the impact on inclusive development

Mr. Supachai Panitchpakdi, Secretary-General of UNCTAD, made opening remarks.

This was followed by a keynote address by Mr. Pascal Lamy, Director-General of the World Trade Organization.

This was followed by an interactive debate moderated by Mr. Guillermo Valles, Director, Division on International Trade in Goods and Services, and Commodities (DITC), UNCTAD.

Statements and interventions were made by representatives of the following member States: Indonesia (on behalf of the Group of 77 and China); the Dominican Republic (on behalf of the Group of Latin American and Caribbean Countries); the Philippines; Honduras; Algeria; Cuba and Bangladesh. In addition, interventions were made by representatives from the non-governmental organizations (NGOs) Southern and Eastern African Trade Information and Negotiations Institute (SEATINI) and Third World Network (TWN).

The following discussants contributed to the debate: Mr. Bernard Hoekman, Director, International Trade Department, World Bank; Mr. Abdallah al-Dardari, Director, Economic Development and Globalization Division, Economic and Social Commission for Western Asia, Beirut; Mr. Ravi Ratnayake, Director, Trade and Investment Division, Economic and Social Commission for Asia and the Pacific, Bangkok; Ms. Virginia Cram-Martos, Director, Trade and Sustainable Land Management Division, Economic Commission for Europe, Geneva; Mr. Andrei Tochin, Director, Trade and Policy Department, Eurasian Economic Commission.

The discussion from the morning session – Key issues arising from the international trading system and the impact on inclusive development – continued. Mr. Guillermo Valles, Director, DITC, UNCTAD, moderated.

The following discussants contributed to the debate: Mr. Sebastian Herreros, Expert, Division of International Trade and Integration, Economic Commission for Latin America and the Caribbean, Santiago; and Mr. Magdhi Farahat, Principal Adviser on Trade, Interregional Advisory Services, Economic Commission for Africa.

The representatives of the Bolivarian Republic of Venezuela and Paraguay made interventions.

Rio+20: How can trade best support sustainable development? Opportunities and costs

H.E. Ambassador Roberto Azevedo, Permanent Representative of Brazil to the World Trade Organization and UNCTAD gave a keynote address.

The following guest speakers made presentations: Mr. Aaron Cosbey, Senior Adviser, International Institute for Sustainable Development; and Mr. Claude Fromageot, Director of Sustainable Development for the Yves Rocher Group and Director of the Yves Rocher Foundation, Paris.

This was followed by an interactive discussion moderated by Mr. Guillermo Valles, Director, DITC, UNCTAD. Representatives of the following member States made interventions: China; Argentina; the Bolivarian Republic of Venezuela; Mexico and Indonesia.

In addition, interventions were made by representatives of the NGOs Centre for Economic and Policy Research/Our World Is Not for Sale (CEPR/OWINFS) and SEATINI.

Mr. Christopher Wunderlich, Coordinator, United Nations Forum on Sustainability Standards, and members of the Division on International Trade in Goods and Services, and Commodities, UNCTAD, also contributed to the discussion.

The President made closing remarks.
