The tables are designed in such a way that they can be used as standalone sources of information.

In November 2015, the United Nations Secretariat introduced a new enterprise resource planning system. The new system posed a challenge for the Organization, because expenditures, contributions and pledges for 2015 were recorded in the legacy system as well as in the new system, which have fundamentally different data structures, coding and charts of accounts. This report is therefore based on preliminary data. Whereas these might differ somewhat from the final data, which will be available later in the year, the differences are not expected to be significant. The financial data in the tables on projects reflect the situation as at 31 December 2015. In early 2015, budget figures were adjusted to reflect exact income. The negative amounts in the 2015 expenditures column pertain to the adjustments of prior year accounts and/or savings on the liquidation of the prior year’s obligations.

Total income 2012–2015 refers to contributions received within that period. In the case of projects financed by the United Nations Development Programme, total income equals total expenditures.

Allotment refers to budget funding for the year.
