Item 3 Review of the technical cooperation activities of UNCTAD and their financing

3. For its consideration of this item, the Working Party will have before it the report of the Secretary-General of UNCTAD on the review of the technical cooperation activities of UNCTAD and their financing (TD/B/WP/297), which deals with activities undertaken in 2018. This report will be submitted both to the Working Party at its seventy-eighth session and to the Trade and Development Board at its next session. The report contains analytical information on the different sources of financing for the technical cooperation activities of UNCTAD, the allocation of technical cooperation resources by type of project, by product (contained in the UNCTAD Toolbox) and by region, as well as an updated overview of the structure and functioning of UNCTAD technical cooperation.

4. Annex I to the above-mentioned report, which is subtitled "Review of activities undertaken in 2018" (TD/B/WP/297/Add.1), provides a review of the technical cooperation activities undertaken in 2018 under various projects and products. It contains background information on the activities, as well as information on their impacts and results.

5. Annex II to the above-mentioned report, which is subtitled "Statistical tables" (TD/B/WP/297/Add.2), provides data on financial contributions, project expenditures and the distribution of expenditures among different regions, products and Sustainable Development Goals. It also provides a list of the projects being implemented in 2018.

6. Under this agenda item, and in accordance with the relevant paragraphs on technical cooperation in the Nairobi Maafikiano and in Trade and Development Board Decision 533 (LXIV), beneficiaries, donors and the secretariat will also have an opportunity to interact and consult on all issues regarding UNCTAD technical cooperation activities.

Evaluation of UNCTAD activities

(a) Evaluation of UNCTAD activities: Overview

7. For its consideration of this item, the Working Party will have before it the report of the Secretary-General of UNCTAD entitled "Evaluation of UNCTAD activities: Overview" (TD/B/WP/298), which presents findings from evaluations conducted between April 2018

and April 2019. The report contains the main messages and recommendations from each evaluation, which may be helpful in informing the assessment, design and future implementation of UNCTAD projects and programmes. The report also highlights lessons learned, addressed specifically to management and programme managers, in planning and implementing projects and programmes.

(b) Synthesis of the five subprogramme evaluations and update on the status of implementation of the recommendations

8. The first cycle of subprogramme evaluations was completed in 2018, with the consideration by the Working Party of the evaluation of UNCTAD subprogramme 5. The secretariat was requested to present to the Working Party a review of evaluation findings from the five evaluations conducted to date and an update on the status of implementation of the recommendations from the evaluations. The synthesis report contains a synthesis and an analysis of the main findings, conclusions and recommendations of the evaluations, with a view to extracting lessons learned, to inform future programming decisions (TD/B/WP/299). The report is accompanied by an update on the status of implementation of the recommendations from the evaluations (TD/B/WP/299/Add.1).
