Tuesday, 23 September 2008

### 1027<sup>th</sup> plenary meeting

The meeting was chaired by H.E. Mr. Debapriya Bhattacharya (Bangladesh), President of the Trade and Development Board.

### Item 12 Other matters in the field of trade and development

(a) **Progressive development of the law of international trade: forty-first annual report of the United Nations Commission on International Trade Law (New York, 16 June-3 July 2008)**

The Board took note of the forty-first annual report of the United Nations Commission on International Trade Law, as contained in document A/63/17, and thus concluded its consideration of this agenda item 12(a).

(b) **Report of the Joint Advisory Group on the International Trade Centre UNCTAD/WTO on its forty-first session (Geneva, 4-5 December 2007)**

H.E. Mr. Malloum Bamanga Abbas (Chad), Chair of the Joint Advisory Group, presented the report.
