Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, Monitoring of Implementation and the Methods of Evaluation

Report of the Secretary-General

1. The Regulations of the United Nations Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation were adopted by the General Assembly in its resolution 37/234 of 21 December 1982. The corresponding Rules were promulgated and issued as ST/SGB/PPBME/Rules/1 (1987) pursuant to General Assembly resolutions 37/234 and 38/227 A of 20 December 1983. The Regulations were subsequently amended by the Assembly in section 1 of its resolution 42/215 of 21 December 1987, to reflect the new budget process established in resolution 41/213 of 19 December 1986.

2. The Regulations were further amended by the General Assembly in section III of its resolution 53/207 of 18 December 1998, as recommended by the Committee for Programme and Coordination at its thirty-eighth session.¹ The Secretary-General has prepared revisions to the Rules (see annex) and, as requested by the Assembly in that resolution, is bringing them to its attention, through the Committee for Programme and Coordination. For ease of reference, the Secretariat has indicated, in the annex, which regulations were revised, replaced or deleted, as well as the new numbering therefor. Explanations are also provided for the revisions to the Rules.

3. The Rules have been revised to bring them into conformity not only with the revised Regulations, but also with current practice following experience gained through application and as a result of changes that have taken place since the promulgation of the current Rules. Examples of such changes include the revised format of the medium-term plan and programme budget, resulting in, for example, the deletion of references to “major programmes”, “programme elements” and “United Nations system”. Some revisions to the Rules also reflect the renumbering of the Regulations, as recommended by the Committee

for Programme and Coordination and approved by the General Assembly, which has, in some instances, made certain rules repetitive or redundant. One new rule has been added, to take into account Regulation 3.2 on the budget process, for which no rule had been previously promulgated; the new rule refers to the deadline of 15 August of the off-budget year for submission by the Secretary-General of the budget outline.

4. The Rules have also been changed to incorporate gender-sensitive language and will be renumbered when the Regulations and Rules are promulgated and reissued as a Secretary-General's Bulletin.

5. The General Assembly may wish to take note of the revised rules.

Regulation 3.2. Budget process

A. Off-budget years

1. The Secretary-General shall submit an outline of the programme budget for the following biennium, which shall contain an indication of the following:

(a) Preliminary estimate of resources to accommodate the proposed programme of activities during the biennium;

(b) Priorities, reflecting general trends of a broad sectoral nature;

(c) Real growth, positive or negative, compared with the previous budget;
