- *To develop applied research and projects on issues of competition regulation.*



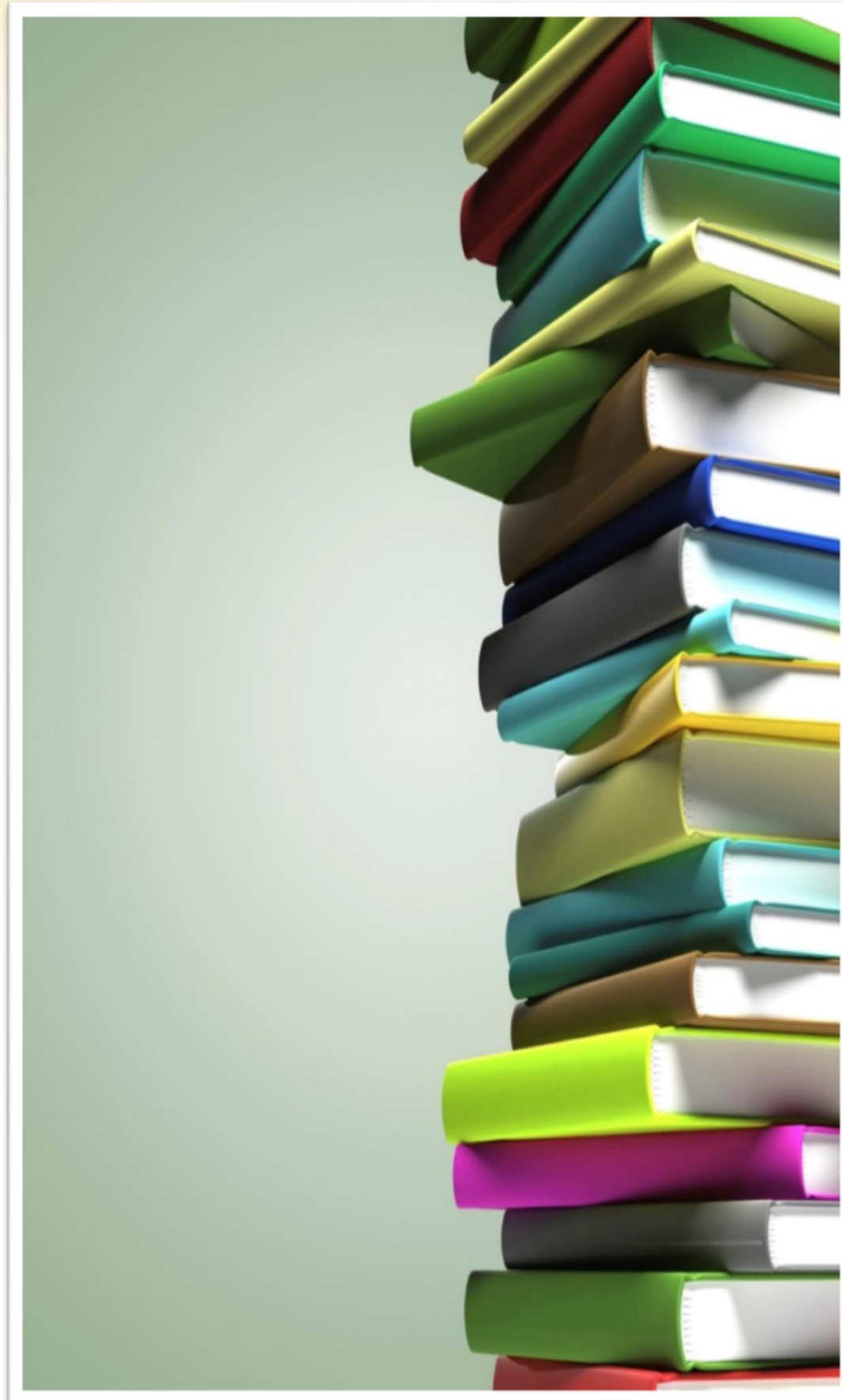
