Intergovernmental Working Group of Experts on International Standards of Accounting and Reporting

Thirty-fourth session Geneva, 1 to 3 November 2017

The thirty-fourth session of the Intergovernmental Working Group of Experts on International Standards of Accounting and Reporting (ISAR) will be held from 1 to 3 November 2017. It will open at 10 a.m. on Wednesday, 1 November, in room XVII of the Palais des Nations in Geneva.

The session will provide an opportunity for member States to discuss key trends in accounting and reporting, and challenges and ways to address them to facilitate high quality and international comparability of corporate reporting for the benefit of financial stability and risk mitigation, an enabling investment climate, and sustainable and inclusive growth. In particular, it will discuss and share good practices on how corporate reporting can contribute to the implementation of the 2030 Agenda for Sustainable Development that has created a new demand on enterprise reporting as a means to assess and enhance the role of the private sector in achieving the Sustainable Development Goals.

In line with the agreed conclusions reached by member States at the thirty-third session of the Intergovernmental Working Group of Experts, the main agenda items for the thirty-fourth session are as follows:

- (a) Enhancing comparability of sustainability reporting: Selection of core indicators for company reporting on the contribution towards the attainment of the Sustainable Development Goals
- (b) The role of disclosures and risk disclosures in enhancing the usefulness of corporate reporting in decision-making.

Additional topics will be considered under "Other business", including a review of the implementation process of the UNCTAD-ISAR Accounting Development Tool in member States; and outcomes of two high-level UNCTAD regional workshops in Africa and Latin America on financial inclusion and accounting for microenterprises and small and medium-sized enterprises.

The UNCTAD secretariat has prepared issue papers on the main agenda items with a view to facilitating experts' deliberations at the session. The provisional annotated agenda and other documentation will be circulated in due course.
