#### Item 3 High-level segment Beyond the curve: UNCTAD and new patterns of growth for trade and development (TD/B/60/7)

The high-level segment will focus on the new geography of global production, trade and finance that has emerged over the past two decades. The global financial crisis has further accentuated these changes. The timing, pace and mode of exiting from crisis-related policies will have a significant impact on growth, trade and development for all countries. National, regional and international policies will have their impact on a smooth and development-friendly recovery. In this process, monetary and fiscal policies, as well as the rules governing financial and international financial systems, will undergo shifts and changes and the role of industrial policies will also be important. Developing countries have started to seek alternative development strategies, focusing on both domestic demand and sectoral diversification for the generation of linkages and productivity growth. Nevertheless, the use of industrial policy to address post-crisis economic challenges is likely to differ across various groups of countries. The systematic treatment by UNCTAD of these topics over the years highlights its potential contribution to elaborating appropriate development strategies for the future.

Deliberations by the Trade and Development Board under this agenda item will provide an opportunity to review how the performance of the world economy has evolved since 2012. It places this analysis within a longer-term perspective showing the rising importance of several developing countries and regions as additional drivers of global economic growth. Special attention will be given to the policies that developed countries and developing and transition economies should adopt to recover sustained growth rates without reproducing the domestic and global imbalances that led to the financial and economic crisis of 2008–2009. As a background document for the Board's deliberations, chapter I of the "Trade and Development Report, 2013" reviews current trends in the world economy, the implications of global economic interdependence for developing countries, the scope for countercyclical and structural policy measures and the need for a concerted response to global economic challenges.

#### Item 8 Development strategies in a globalized world: Growing domestic and regional demand for balanced and sustainable growth

(UNCTAD/TDR/2013, chapters II-VI)

Deliberations by the Trade and Development Board under this agenda item will focus on the need for active policies to strengthen domestic and regional markets on the demand side and productive upgrading and diversification on the supply side, as the driving principles underpinning long-term development strategies. The current financial and economic crisis is more than just a cyclical episode; it represents a breaking point, after which it will be neither possible nor desirable to return to pre-crisis growth patterns. In many cases development strategies will have to be refocused. Countries will have to strengthen domestic and regional consumption and investment, which in turn will generate imports demand and trade. Global or (at least) regional coordination are important for the sustainability of this process.

# Item 9 Investment for development: Global value chains and development

#### (UNCTAD/WIR/2013 and Overview)

With the rise of global value chains (GVCs), a tradeinvestment nexus permeates and defines today's global economy. The vast preponderance of global trade is ultimately governed by transnational corporations, which orchestrate and coordinate GVCs through foreign direct investment, non-equity modes (such as services outsourcing, contract farming and contract manufacturing) and cross-border transactions with independent firms. There are both opportunities and risks associated with GVCs for developing countries. They need to carefully weigh the pros and cons of GVC participation and the costs and benefits of proactive policies to promote GVCs or GVC-led development strategies, in line with their specific situation. Some countries may decide not to promote it; others may not have a choice. In reality, most are already involved in GVCs to a degree. Policy matters to make GVCs work for development. The Board session will also provide an opportunity for a briefing by the secretariat on the latest developments on foreign direct investment trends and policies.

#### Item 6 Economic Development in Africa: Intra-African trade: Unlocking private sector dynamism (TD/B/60/4 and UNCTAD/ALDC/AFRICA/2013)

This agenda item will consider the report, "Economic Development in Africa: Intra-African Trade: Unlocking Private Sector Dynamism", which examines how to strengthen the private sector to boost intra-African trade. The report argues that for countries in Africa to reap expected gains from intra-African trade and regional integration, they will need to place the building of productive capacities and domestic entrepreneurship at the heart of the policy agenda for boosting intra-African trade. In this context, the report recommends that Governments in Africa should promote intra-African trade in the context of developmental regionalism. In particular, it stresses the need for a shift from a process and linear approach to integration, which focuses on elimination of trade barriers, to a more development-based approach to integration, which pays as much attention to the building of productive capacities and private sector development as to the elimination of trade barriers.
