#### INTRODUCTION

Trade facilitation is receiving increasing attention and investment at the national, regional and multilateral levels, especially in the context of the World Trade Organization Agreement on Trade Facilitation concluded in Bali, Indonesia. At the same time, the increasing number of regional trade agreements may pose additional challenges to trade facilitation, though can also promote trade facilitation reform and a further global harmonization of rules.

The second session of the Multi-year Expert Meeting on Transport, Trade Logistics and Trade Facilitation will address some of the specific issues that developing countries face in designing and implementing national and regional trade facilitation reforms, taking into consideration the new World Trade Organization Agreement on Trade Facilitation.
