Background

Affordable, reliable and sustainable energy provision is critical for powering structural transformation in the least developed countries (LDCs) and enabling their transition towards a low-carbon economy. Ensuring universal access to energy is hence fundamental to achieve LDCs' sustainable development objectives. The relevance of energy issues is even greater in the context of the 2030 Agenda for Sustainable Development, which includes a dedicated Sustainable Development Goal (Goal 7, "Ensure access to affordable, reliable, sustainable and modern energy for all"), as well as two more Goals directly linked to the theme (Goal 9, "Build resilient infrastructure, promote inclusive and sustainable industrialization and foster innovation", and Goal 12, "Ensure sustainable consumption and production patterns").

The panel will discuss the following questions:

- How should LDCs best steer their sustainable energy mix to support structural transformation and poverty eradication?
- What are the possible financing alternatives to cover LDCs' huge energy investment needs?
- What is the potential for more energy-efficient technologies and cost reductions in renewable energy (including biofuel technologies) in LDCs?
- To what extent do the current energy policy choices of LDCs condition the longer-term composition of output, employment and trade in these countries?
