In addition, trade facilitation reforms can directly assist in advancing other critical development objectives, such as strengthening governance and transparency, building human and institutional capacities and formalizing the informal sector. Trade facilitation requires broad-based collaboration at both national and regional levels, between all relevant public and private stakeholders in the trade transaction chain, through public-private partnerships, notably national trade facilitation committees. Such committees are an important element in the implementation of the Agreement on Trade Facilitation Agreement of the World Trade Organization.
