#### **Background**

Sustainable, affordable and clean energy plays an essential role in achieving the SDGs. The key role of access to modern energy in attaining the social SDGs is generally accepted, but interpretation and implementation of SDG7 has focused on household access and basic needs. Transformative energy access - an approach to universal access that goes beyond basic household needs to provide the means for structural transformation of LDCs' economies through the development of more productive and modern activities and sectors - has been proposed by *The Least Developed Countries Report 2017*. This points to the question of how LDCs can reach transformational energy access.

The Panel will discuss the following questions:

- How can wider energy access contribute to accelerating economic and social progress in LDCs?
- What policies are LDCs putting in place to reach transformation energy access?
- What efforts is the international community undertaking in order to accelerate progress towards Sustainable Development Goal 7?
- What can be expected from the High-Level Political Forum 2018?
