Implementation of the United Nations Set of Principles on Competition Policy

Since the Seventh Review Conference held in 2015, many jurisdictions, including developing countries and countries with economies in transition, have newly enacted or substantially revised their competition, aiming to strengthen and improve their competition policy and enforcement. Among them, regional organisations, especially among developing countries, have adopted and implemented regional competition rules, while other cooperation arrangements have also been flourishing for a more effective competition law enforcement.

Needless to say, anticompetitive conducts and mergers are increasingly cross-border with the progress of globalisation and the development of the digital economy. This calls for enhanced cooperation amongst competition authorities at bilateral, regional, and international levels. Cooperation may be easier to be launched at regional level, given that neighbouring countries usually have similar backgrounds and legal frameworks, share common interests, mutual benefits and have a better understanding of each other.

Therefore, this session will look at new and revised competition laws as well as the progress of regional level activities especially since 2015, the benefits of regional competition frameworks, and the current and future challenges which competition legal and institutional frameworks are facing, in particular for developing countries.

Speakers from a variety of regions are invited to present their views and experiences on the following points:

- (a) objectives of recently adopted/revised competition laws;
- (b) benefits and challenges of regional competition frameworks, including the relationship between regional authorities and member States' authorities;
- (c) keys to successful regional competition frameworks.
