Former multi-agency group/committee: The BCCC is part of the pre-existing well-functioning networks that Canada uses to coordinate trade facilitation domestically and is used to liaise with private sector stakeholders.

Monitoring and evaluation: The BCCC Secretariat logs progress and tracks action items from the Records of Meetings.

Reporting form and supervisory authority: Working groups report to the three Committees that make up the BCCC.

Membership / Composition:

Public or quasi-public agencies: Public domain membership is comprised of internal (CBSA) members.

Private associations or entities: Industry membership is comprised of approximately 25 national associations which include importers, exporters, carriers in all modes of transport, customs brokers, freight forwarders, warehouses, and manufacturers.

Level of seniority of participants: High-level government officials comprising CBSA Director Generals, Directors, Managers; Industry stakeholders are Presidents, Managers, and Advisors.

Participation:

Frequency of meetings: Twice a year, May and November, for one or two days, though meetings can occur more frequently at the discretion of the Chairs.

Level of participation: Almost complete membership attendance or representation through alternates.

Meetings format: Presentations and round table discussion, in person; there is also WebEx available.

Communication channels to keep stakeholders informed of TF meetings: The agenda and associated material are sent to each member prior to the time of the meetings. A Draft Record of Decision is published shortly after the meetings. The Secretariat serves as a liaison between the three committees, and the BCCC membership. Additionally, the Secretariat ensures action items identified during each meeting are monitored until resolution and decisions are communicated to all affected parties.
