### **Funding**:

Budget: No, the working group does not yet have an operating budget. However, it receives an annual grant from the West African Economic and Monetary Union (UEMOA)

**Sources of funding**: Eventually the State budget and the contribution from private and international organizations.

Items covered by the budget: The main activities that this budget could have financed are: Committee meetings, training of members, the activities of the technical working groups and the information and awareness-raising meetings of the public and stakeholders.

### **Objectives / Focus:**

Objectives: Coordinate implementation, and make recommendations and assessments of the implementation of these recommendations.

Working plan: Yes the committee has a work plan and an annual action plan.

Monitoring and evaluation: It is thought that to the extent of 100% the NTFC fulfils its role of monitoring and evaluating the implementation of the WTO Trade Facilitation Agreement. Monitoring channels: Consultations with stakeholders and Reports.

Evaluation channels: Focus groups and Reports of work.

Familiar with the following tools: World Bank Doing Business Trading Across Borders, World Bank Logistics Performance Index (LPI), World Economic Forum Global Enabling Trade Report. Familiar with the following tools to some extent: UNCTAD statistics (country and maritime profiles), UN Global Survey on Trade Facilitation and Paperless Trade Implementation, OECD Trade Facilitation Indicators.

Reporting form and supervisory authority: The group makes periodic and annual reports to the Minister for Trade and the Prime Minister.

Interface with other working groups/committees on similar issues: The committee organizes extended meetings for these groups National Committee for Sanitary and Phytosanitary Measures, National Committee for International Trade Negotiations, National Committee for Transport Facilitation.

**Undertake information sessions to stakeholders or general public**: Yes, information and awareness workshops are organized for the public and interested parties. Also through TV and radio.

### Benefits:

**Impact**: Strengthening public-private partnership in the monitoring and implementation of the Trade Facilitation Agreement. This helps to identify concerns and facilitate collaboration between the agencies involved in international trade.

**Benefits for the country's responsiveness to the WTO negotiation process**: By reflections and presentations of the positions of the country on subjects under negotiation in the WTO in relation to the Permanent Mission of Togo in Geneva and also to the effective implementation of the agreements.

**Concrete operational outcomes**: Implementation of concrete trade facilitation measures, Developed an implementation plan for the WTO Trade Facilitation Agreement, Improved coordination,

Ratification / notifications of the Trade Facilitation Agreement sent to the WTO, Raise awareness on the importance of trade facilitation.

### Lessons learned:

**Success factors**: It is thought that to the extent of 99% the Committee is sustainable in time. Crucial factors to the sustainability are as follows: Cooperation among members / Common understanding and goals, Financial assistance / adequate resources, Capacity building,Political commitment / high level support,and Involvement of the private sector.

**Greatest obstacles**: Lack of funding / resources,Lack of awareness of importance of NTFC / understanding of trade facilitation, and Resistance to change.

**Lessons learned from your experience**: Synergy between public administrations and private organizations.
