Degree of institutionalisation: A ministerial decree from State Minister of Trade.

Coordinating agency: Ministry of Trade

Scope/mandate: The mandate is to work on all trade facilitation matters.

Terms of reference: Yes Sudan's National Trade Facilitation Committee - Terms of Reference

Working structure of the group: Chair

Permanent technical secretariat: Yes. Ministry of Cabinet hosts the permanent secretariat. Four people hosts the permanent secretariat.

Funding:

Budget: No. This is because the lack of domestic resources and the lack of financial support of donors and development partners.

Budget will be needed for: Office rental and equipment, Software tools, Reproduction and publications services, Telephones and internet, Translation services, Meeting venues and catering, Training sessions, Public information sessions and media outreach.

Sources of funding: Some financial assistance from some member agencies in the working group like Customs, Standards and Cleaning agents.

Benefits:

Impact: It has good impact on sensitizing stakeholders and the public on the importance of trade facilitation

Benefits for the country's responsiveness to the WTO negotiation process: It linked activities in Trade Facilitation in Sudan with WTO negotiation and provided a good opportunity to meet with donors in the Negotiating Group on Trade Facilitation in the WTO.

Concrete operational outcomes: Negotiation of trade or trade facilitation agreements, Implementation of concrete trade facilitation measures, Improve transparency / dialogue, Developed an implementation plan for the WTO Trade Facilitation Agreement, Improved coordination, Improve business environment for traders, Reduction of time and / or improvement of procedures at the border, Reduction of costs of import, export and / or transit, Raise awareness on the importance of trade facilitation, Mainstreaming trade facilitation into other national policies

Lessons learned:

Success factors: It is thought that to the extent of 93% the NTFC is sustainable in time. Crucial factors to the sustainability of the NTFC are as follows: Clear responsibility of participants, Financial assistance / adequate resources, Involvement of the private sector, Awareness raising on trade facilitation, Development of work plans and proposals

Greatest obstacles: Lack of funding / resources,Incorrect representation of members / frequent replacement of members,High level support / political buy-in,Resistance to change,Lack of regularity of meetings

Lessons learned from your experience: National working groups are proper mechanisms for coordination between border agencies to facilitate trade.

Future plans:

Plans for further development: To work actively to implement UNCTAD plan of implementation of Trade Facilitation measures with assistance from UNCTAD, WTO and other Annex D organisations and Donors.
