Working plan: Yes, there is the National Trade Facilitation Action Plan.

Monitoring and evaluation: It is thought that to the extent of 73% the NTFC fulfils its role of monitoring and evaluating the implementation of the WTO Trade Facilitation Agreement.

Monitoring tools: Baselines and Targets.

Evaluation tools: Surveys distributed by the NTFC among trade facilitation stakeholders.

Gender:

Percentage of female in the committee: Membership is by institution not individual persons as such this might be difficult to apply.

However, going by previous NTFC records of attendance, female representations ranges between 28 to 42%.

Chairman / President / Vice-president is female: The Chairperson is the Commissioner General of Malawi Revenue Authority. The current Commissioner General is a female.

Comittee did decide on gender mainstreaming TF in the past: No. As mentioned above that membership is by institution it will be important to urge institutions to consider female representation in the NTFC meetings.

If no, why not. (Example: It not considered a priority, not considered relevant at this stage, lack of awareness, etc): It is because membership is by institution and it is the prerogative of the institution to send their preferred representation.

If no, explain future plan in this area.: Feasibility of the matter will be proposed on the agenda for discussion in the next NTFC meeting

Promotion / Communication:

Communication channels to keep stakeholders informed of TF meetings: 1.Communication via emails and letters

2.NTFC Secretariat maintains a list of contact persons for all member institutions

Interface with other working groups/committees on similar issues: 1.Some members of the NTFC also participate in meetings of working groups/committees on trade facilitation matters

2.Furthermore NTFC Secretariat makes presentations to other forums whenever demanded

Interface with other working groups/committees on similar issues: Some members of the National Trade Facilitation Committee also participate in meetings of working groups/committees on trade facilitation matters. Furthermore, National Trade Facilitation Committee makes presentations to other forums whenever demanded (e.g. presentation done to Cabinet Committee on Doing Business last April, and the National Working Group on Trade Policy meeting in June, 2016).

Impact: The Malawi National Trade Facilitation Committee has managed to contribute to the development of the Malawi Trade Portal thereby enhancing transparency and predictability of trade transactions. It has coordinated the One Stop Border Posts project, the National Single Window Projects, and capacity building trainings. It has also coordinated some studies on export ban and on domestication of international agreements.

Benefits for the country's responsiveness to the WTO negotiation process: It is a forum where discussions on topical issues are discussed and recommendations made where national negotiating positions are developed.

Concrete operational outcomes: Launch of the Malawi Trade Portal in July 2016;

Launch of One Stop Border Post with Zambia and Tanzania;

Implementation of concrete trade facilitation measures;

Developed an implementation plan for the WTO Trade Facilitation Agreement;

Improved coordination;

Ratification / notifications of the Trade Facilitation Agreement sent to the WTO;

Reduction of time and / or improvement of procedures at the border;

Raise awareness on the importance of trade facilitation;

Mainstreaming trade facilitation into other national policies.

Lessons learned:

Success factors: It is thought that to the extent of 65% the NTFC is sustainable in time. Crucial factors to the sustainability of the NTFC are as follows: Clear responsibility of participants, Commitment from members, Financial assistance / adequate resources, Political commitment / high level support, and Involvement of the private sector.

Greatest obstacles: Lack of funding / resources, Incorrect representation of members / frequent replacement of members, and Lack of awareness of importance of NTFC / understanding of trade facilitation

Lessons learned from your experience: Coordination among members and presence of senior level members during meetings are crucial.

Future plans:

Plans for further development: Regional integration has been considered to some extent within the work of the NTFC.
