Millennium Challenge Corporation Indicators on Government Effectives; Corruption; Business Start Up; etc. UNSAID/Deloitte (Liberia Trade Policy and Customs Project) provided the initial technical assistance.

Ministry of Commerce and Industry – Deputy Minister of Commerce and Trade Services – Chair Ministry of Finance and Development Planning – Deputy Minister Economic Management (or designated representative)

Liberia Revenue Authority – Bureau of Customs & Excise (or delegated representative)

Ministry of Transport – National Ports Authority - role (or delegated representative)

Ministry of Justice – Deputy Minister for Economic Affairs (or delegated representative)
