Official name: National Committee for Trade Facilitation (CONFACO)

Year of establishment: The National Committee for Trade Facilitation (CONFACO) was created by

Executive Decree Number PCM - 039-2018 dated July 20, 2018.

Motivation for its establishment: The creation of the committee was motivated by the commitments acquired by Honduras as a member of the WTO, and to comply with the provisions of Article 23.2 of the Agreement on Trade Facilitation which establishes the commitment that each member establishes and / or will maintain a Committee National Trade Facilitation or designate an existing mechanism to facilitate internal coordination and implementation of the provisions of the Agreement in question.

Other national bodies dealing with WTO issues and/or with Trade Facilitation: In commercial facilitation, specifically, no, but there is also the National Logistics Council that coordinates national efforts to make Honduras the regional logistics hub.

Former multi-agency group/committee: No

Current status of the working group (running, pilot phase, not functioning, etc): The Committee is underway, in the middle of the year an AFC compliance analysis was concluded through an article-by-article review with all government institutions that are key actors in their compliance and with the private sector present always providing observations and recommendations. The Committee is currently developing a strategic plan through the technicians of the institutions to work in compliance with the AFC taking into consideration its three categories and the time taken to comply with the articles.

Institutional Framework:

Degree of institutionalisation: The document was the Protocol of Amendment to the Marrakech Agreement establishing the World Trade Organization, to insert the Agreement on Trade Facilitation.DECREE N ° 146-2015 dated December 17, 2015.

Type of organisation (ad hoc group, legal entity/organisation, etc): Legal Entity composed of officials from various government entities and the private sector.

Coordinating agency: The Secretary of State in the Economic Development Office.

Scope/mandate: The scope of the National Committee for Trade Facilitation is at the National Level.

Working structure of the group: The CONFACO will be chaired and coordinated by the Secretary of State in the Economic Development Office, through the Undersecretariat for Economic Integration

The CONFACO will be composed of a representative and a substitute representative of the public and private sectors as follows:

- 1. Secretary of State in the Economic Development Office, through the Undersecretariat for Economic Integration and Foreign Trade, who will chair and coordinate the Committee;
- 2. Secretary of State in the Offices of Agriculture and Livestock through the Undersecretariat of Livestock and the National Service of Agrifood Health and Safety (SENASA);
- 3. State Secretariat in the Health Office through the Undersecretariat of Integrated Health Services Networks;
- 4. Secretary of State in the Security Office through the Secretariat for Security in Interinstitutional Affairs and the National Directorate of Border Police Services;
- 5. Secretary of State in the Office of Infrastructure and Public Services through the Undersecretariat of Transportation;
- 6. Secretary of State in the Finance Office through the Undersecretariat of Finance and Budget;
- 7. Presidential Commission for Integral Reform of the Customs System and Trade Operators (COPRISAO) through its President Commissioner and the Deputy Directorate of Customs Revenue;
- 8. Health Regulation Agency through its President Commissioner; and,
- 9. National Migration Institute (INM).

From the private sector:

- 1. Honduran Council of Private Enterprise
