#### Motivation for its establishment:

The isolation of the Central African Republic raises many problems both in exports and imports; At the Douala port, traders complain about the difficulty and long delay of Customs administrative procedures for goods in transit;

There are illegal barriers to the free movement of goods;

Illegal taxes are levied on goods;

There are road and police harassment;

The state of the roads is not good, often blocked during the rainy season;

Lack of adequate infrastructure to facilitate trade with neighbouring countries;

The border checkpoints do not have informatics tools;

Border agents disregard the regulations and they are not trained;

Lack of material resources to do technical services work;

Lack of coordination between the technical services: and

Shortage of products on the market and high prices. So, the business environment is not appropriate.

Other national bodies dealing with WTO issues and/or with Trade Facilitation: The Ministry of Trade and Industry is the public body responsible for monitoring WTO files, in collaboration with the structures involved in implementing CAR trade policies. There is the National Committee for Trade Negotiations (CNNC) which deals not only with the WTO file but also with other questions such as the EPA, AGOA, ZLECAF
