

Note by the UNCTAD secretariat

- 1. Paragraph 14 of General Assembly resolution 1995 (XIX) provides that, when the Conference is not in session, the Trade and Development Board shall carry out the functions that fall within the competence of the Conference. Paragraph 22 provides that the Board shall report to the Conference and that it shall also report annually on its activities to the General Assembly.
