The session is devoted to the HPPCD for Ethiopia, which results from a careful assessment of the country's gaps and limitations in fostering productive capacities and structural economic transformation. The HPPCD builds on evidence-based and data-driven assessments using the Productive Capacities Index (PCI,) which served as the basis for formulating the National Productive Capacities Gap Assessment (NPCGA) for Ethiopia. The Programme is designed to tap the comparative advantages of Ethiopia and relieve the key binding constraints to the country's development as articulated in the NPCGA. The aim is to exchange views on the way forward across key pillars of the Programme. It also aims to provide a platform for discussion on the HPPCD's contribution to the achievement of the objectives of Ethiopia's Ten Years Development Plan 2021-2030, to the long-term development strategy and to ensuring inclusive and sustainable development. The discussion will focus on the pillars of the Holistic Programme: Pillar I: Agriculture





modernisation, manufacturing and value addition; Pillar II: International trade and integration; Pillar III: Infrastructure (including transport, energy, and water); Pillar IV: Innovation and technology development; Pillar V: Human development and private sector; Pillar VI: Institution building and coordination. The final part of the session will be concerned with the role of development partnership and the alignment of donor support programmes.
