

- WTO member since 1995 and GATT since 1948.
- Trade Facilitation Agreement ratified in 2015
- Developing country of South Asia with GDP of 376 Billion USD (World Bank 2022)
- Currently ranked as 41st major economy (GDP) of the world
- Share in Global trade is approximately 1%

- Corporate governance model, Inter-ministerial oversight
