Context

Trade, while a significant contributor to plastic pollution, can be also wielded to bolster plastic action efforts across borders. Discussions on an international legally binding instrument (ILBI) to end plastic pollution are exploring the role of trade policy in a future global plastic treaty. Thanks to the Dialogue on Plastic Pollution (DPP), a plurilateral initiative under the auspices of the World Trade Organization (WTO), countries are increasingly interested in the nexus between trade and plastic pollution reduction. This informal side event will gather negotiators, the private sector and civil society leaders to discuss specific trade policy opportunities in support of the ILBI.
