





# Multi-Stakeholder Workshop on the Roadmap to Support STI Parks in Uzbekistan

## Programme

#### 6 May – 8 May 2025

#### Tashkent, Uzbekistan

**Objective.** The Multi-Stakeholder Workshop on Science, Technology and Innovation (STI) Park Policies and Practices aims to advance the development of STI parks in Uzbekistan by fostering stakeholder consensus on the way forward, building on insights from previous capacity-building workshops in China and Uzbekistan. The workshop will support the development of a draft STI park roadmap and action plan, ensuring alignment with national innovation priorities. It will focus on international best practices, financial and non-financial support mechanisms, technology transfer and commercialization, incubation and acceleration, investment attraction and multi-stakeholder collaboration. Through expert presentations, case studies and interactive discussions, participants will engage in identifying challenges, proposing solutions and strengthening partnerships to enhance the effectiveness and sustainability of STI parks in Uzbekistan.

**Target audience.** This multi-stakeholder workshop will bring together key actors involved in STI park development and policymaking in Uzbekistan, including:

- Policymakers, including representatives from the Ministry of Higher Education, Science and Technology, the Ministry of Industry, the Ministry of Finance and other relevant government agencies
- STI park managers, incubator and accelerator operators, including representatives from full-fledged STI parks, technology parks, innovation hubs, incubators, start-up studios, industrial techno-parks and special economic zones or free trade zones hosting STI-related activities
- Industry representatives, such as members of industrial associations
- Startups and firms operating in STI parks, incubators and accelerators
- Women entrepreneurs' Association and Youth entrepreneurs' Association
- Academia, researchers and experts engaged in STI-focused policy and STI park development

The diverse mix of participants will help strengthen multi-stakeholder partnerships, which are essential for ensuring the long-term success of STI parks as drivers of innovation-led economic growth in Uzbekistan.
