- (b) Report of the Joint Advisory Group on the International Trade Centre

The Chair of the Joint Advisory Group, H. E. Ms. Patricia O'Brien (Ireland), introduced the report of the Joint Advisory Group on its forty-ninth session.

The Board heard statements from the following delegations: the Philippines, on behalf of the Group of 77 and China; and Morocco. The representative of the International Trade Centre also made comments.

The Board took note of the report of the Joint Advisory Group at its forty-ninth session and concluded its consideration of the item.

Item 5 Economic development in Africa: Unlocking the potential of Africa's services trade for growth and development

The Secretary-General of UNCTAD, Mr. Mukhisa Kituyi, made an opening statement and introduced the item under consideration. This was followed by a presentation of the *Economic Development in Africa Report 2015* by the Director of the Division for Africa, Least Developed Countries and Special Programmes of UNCTAD, Mr. Taffere Tesfachew.

Statements were made by the following members States and regional groups: the Philippines, on behalf of the Group of 77 and China; the United Republic of Tanzania, on behalf of the Africa Group; Brazil, on behalf of the Latin American and Caribbean Group; the European Union, on behalf of the European Union and its member States; Benin, on behalf of the least developed countries; Paraguay, on behalf of landlocked developing countries; Ethiopia; Kenya; Zimbabwe; the United Kingdom of Great Britain and Northern Ireland; the United States of America; Tunisia; Morocco; China; and Japan.

Sessional Committee II - First informal meeting

Item 5 Economic development in Africa: Unlocking the potential of Africa's services trade for growth and development (continued)

The Deputy Secretary-General of UNCTAD, Mr. Joakim Reiter, opened the informal session by highlighting the areas to be explored by the panel.

The Sessional Committee heard presentations by various panellists. Mr. Ibrahim Murtala, Deputy Minister of Trade and Industry, Ghana, discussed his country's services trade regime with an emphasis on measures to enhance the potential of services trade export. Mr. Anders Aeroe, Director, Division of Market Development, International Trade Centre, focused on two topics: principles for effective policies that enabled services to make valuable contributions to African economies, and the services negotiation agenda in multilateral negotiations. Mr. Charles Adjasi, Professor, University of Stellenbosch Business School, Cape Town, South Africa, described a pan-African approach to enhancing opportunities for services growth in Africa. Mr. Patrick Low, Fung Global Institute, Hong Kong (China), discussed the role of services in global value

chains, and Mr. Juan Marchetti, Counsellor, Trade in Services Division, World Trade Organization, discussed the interaction between domestic and multilateral financial services regulation.

The interactive debate that followed featured statements by the following delegations: Uganda; Canada, on behalf of JUSSCANNZ; the United States of America; Morocco; South Africa; Côte d'Ivoire; Kenya; and Morocco.

The panellists and Mr. Taffere Tesfachew, Director, Division for Africa, Least Developed Countries and Special Programmes, replied to questions from the floor.

The Board thus concluded its consideration of this agenda item.
