#### Sessional Committee I – First plenary meeting

#### Item 4 Contribution of UNCTAD to the implementation of the Programme of Action for the Least Developed Countries for the Decade 2011–2020: Fourth progress report

Sessional Committee I was opened by the Chair of the Committee, H.E. Ambassador Eloi Laourou (Benin). The Committee elected Mr. Faical Souissi (Morocco) as Vice-Chair-cum-Rapporteur.

Sessional Committee I began its consideration of item 4 with opening remarks by the Deputy Secretary-General of UNCTAD, Mr. Joakim Reiter, This was followed by an introduction of the background document by Mr. Taffere Tesfachew, Director of the Division for Africa, Least Developed Countries and Special Programmes.

Statements were made by the following delegations: the Philippines, on behalf of the Group of 77 and China; the United Republic of Tanzania, on behalf of the African Group; Cuba, on behalf of the Latin American and Caribbean Group; the European Union, on behalf of the European Union and its member States; Canada, on behalf of JUSSCANNZ; Benin, on behalf of the least developed countries; Paraguay, on behalf of the landlocked developing countries; Nepal; China; Morocco; Ethiopia; and South Africa.
