### **Bios of the Speakers and Moderators**

#### **Janvier Nkurunziza, Chief of CRAS, Commodities Branch, Division on International Trade and Commodities, UNCTAD**

Janvier Désiré Nkurunziza is the Chief of Research and Analysis Section in the Commodities Branch, UNCTAD where he directs research on the interaction between primary commodities production, trade, and economic development. For several years, Janvier has been a resource person in the African Economic Research Consortium, a research and capacity building network based in Africa. Before his current position in UNCTAD, Janvier was the officer-in-Charge of the Africa Section, UNCTAD; Macroeconomic Policy Advisor at UNDP, New York; and an economist at UNCTAD and UNECA. Janvier also worked at the University of Oxford; Harvard University; the University of Yaoundé; the University of Burundi; the IMF; the World Bank and the University of Yale as a Consultant. He has published dozens of articles in internationally peer reviewed journals and chapters in edited books. He has coordinated the production of flagship reports, including: UNCTAD's Commodities and Development Report, and Economic Development in Africa Report; the African Economic Outlook; and UNECA's Economic Report on Africa. He holds a doctorate in Economics from the University of Oxford, where he is affiliated with the Center for the Study of African Economies. Janvier is a Fellow of several academic and research institutions. His recent research has focused on commodities and development; the economics of civil war and conflict; capital flight and illicit financial flows; and financial systems in Africa.

#### **H.E. Mr. Eloi Laourou, Ambassador, Permanent Representative of Benin to the United Nations Office and other International Organizations Based in Geneva and Vienna**

Diplomat of Career, with more than 32 years of professional experience in the Diplomatic Function. Previously Coordinator of the Group of the Least Developed Countries (LDC) in the WTO (Year 2016), he is Co-Chairman of the Working Group on Trade and Development of the Francophonie in Geneva, and Chair of the WTO Trade Policy Review Body (Year 2018). #### **Holger Matthey, Economist, Food and Agriculture Organization of the United Nation (FAO)**

Holger Matthey has been working on medium term projections for about 15 years and is now leading the Medium-term Outlook and Market Analysis Team of the Trade and Markets Division at the Food and Agricultural Organization of the United Nations. The team produces the annual OECD-FAO Agricultural Outlook and conducts studies assessing emerging issues and their impact on global and domestic agricultural commodity markets. Holger joined FAO in 2004 as an Oilseeds Analyst, before that he was an Associate Scientist at the Food and Agricultural Policy Research Institute (FAPRI) at Iowa State University conducting domestic and international policy analysis. He started his career in agribusiness in former East Germany developing business plans for the restructuring of large collective farms. Holger holds a Ph.D. in agricultural economics from the University of Nebraska (USA)

**Darren Cooper, Senior Economist, International Grains Council**

Darren has spent two decades in the commodities sector, in a range of roles, covering different markets and industries, including mining and metals, tropical commodities, dry bulk freight and agriculture, notably grains, rice and oilseeds. He has travelled extensively and presented on a range of topics at international events. In 2006, he joined the International Grains Council, a London-based intergovernmental organisation, as a Senior Economist, with experience spanning all of the body's activities.

**Christoph Sanger, Senior Economist, International Coffee Organization**

Christoph Sanger is Senior Economist at the International Coffee Organization (ICO) in London, conducting research on coffee value chains in Africa, Asia and Latin America. Prior to joining the ICO he was economist at the European Bank for Reconstruction and Development where he carried out sector and project evaluations to support the design of agribusiness investments in Eastern Europe, Central Asia, and Northern Africa. He has previously worked in the Division for International Cooperation at the Federal Ministry of Agriculture in Berlin. He received his MS degree from University of California, Davis, USA and holds a PhD in Agricultural Economics from Georg-August-Universitat Gottingen, Germany.

**Laurent Pipitone, Consultant, Director & co-founder, FarmBridge International, London, UK**

Laurent Pipitone is a development economist, with 14 years of experience in the cocoa sector. Until 2017, he served as Economics Director of the International Cocoa Organization (ICCO). As such he was responsible for implementing the sustainability agenda of the Organization. He led and conducted economics studies on the cocoa sector, analysed market developments, supervised and implemented development projects and capacity building seminars in producing countries, and organised the World Cocoa Conference every 2 years. Since leaving the ICCO, Laurent has been working as a consultant, conducting economic studies on the agricultural sector in developing countries, as well as advising clients of leading international consultancy firms, and cocoa and chocolate companies. He recently co-founded FarmBridge International to assist cooperatives and farmers to address challenges faced to market their produce. Laurent holds a MSc in Macroeconomics Analysis and Economic Modelling applied to environmental issues and a Magistère in Economics from the University of Paris I Pantheon - Sorbonne.

**Guillaume Albasini, Energy and Mining Analyst, Geneva**

**Horacio M. Jurado, Director, Directorate of Mining Value Chain, Sustainability Undersecretariat, Ministry of Energy and Mining of the Republic of Argentina**

Horacio M. Jurado has more than 20 years in mining and automotive companies, developing and implementing continuous improvement strategies, cost reduction initiatives, quality management systems and productive efficiency projects. Aeronautical Engineer from Universidad Tecnológica Nacional, with a specialization in Quality Engineering and an MBA. As part of the Sustainability Undersecretariat, the main role is to develop strategies to increase competitiveness of the Argentinian METS (Mining equipment, Technologies and Services) in order to provide a range of solutions to mining industry needs. With focus on SMEs, looking for different tools to improve supplier's performance, such as financial advice, technical support and staff training, among others. Following mining industry trends about new skills, others activities include policy developments to support new academic programs. Before joined the public sector, I worked in a private mining company for about 10 years in Production processes, Strategic planning, Talent management and People development. Prior to mining, I worked in car industry for over 10 years, in several projects about supplier development, quality management and customer service.

Rodrigo Cárcamo Díaz is Economic Affairs officer at the the Commodities Branch of UNCTAD where he carries out research on the relationships between commodities and economic development, with a focus on economic diversification. Previously, after working as a competition policy consultant in the UK, for 15 years he was Economic Affairs Officer working at the United Nations ECLAC, where he was country economist for different countries, and carried out research on macroeconomic cooperation among commodity producing countries and several other growth and development-related topics. He has worked too in different development projects, like the REDIMA project he coordinated, which led to his publication of a book in 2012. He has also published several articles, working papers, book chapters and contributed to different UN and other institutions' publications. Prof. Mwinyikione Mwinyihija, is a chartered Fellow of various acclaimed internationally recognized professional organizations where he is currently serving Africa Leather and Leather Products Institute (ALLPI), formerly called COMESA/LLPI, as Executive Director since 2013. He holds Degrees in the following fields: Ecotoxicology of the tanning Industry, Management and Remediation of Tannery Waste, Opportunity management; Value addition strategy for the leather sector; and Management Sciences. Before joining ALLPI, Prof. Mwinyihija was CEO of the Kenya Leather Development Council coupled with over 20years working with the leather sector at various levels in Government service. Currently, he provides leadership in the leather sector in disciplines such as Ecotoxicology and Value Chain Analysis of the leather sector. He is also a mentor, reviewer, examiner, researcher, author and publisher of peer reviewed books, papers and presentations related to the leather sector to regional and global arenas His involvement to the leather industry, leadership quality and collaborative relationships has greatly assisted in the successful attainment of illustrious milestone regionally and globally associated institutions. He has been participating as Member of the IULTCS Congress Scientific Committee for the last four Congresses. **Gothami Silva, Director of Commerce, Department of Commerce (DoC), Sri Lanka**
