I. Overview

The training workshop for investment promotion stakeholders in Togo included 88 government officials representing 24 government institutions including the Office of the Prime Minister, the Ministry of Investment Promotion, the investment promotion agency of Togo (API-ZF), ministries of foreign affairs, economy and finance, the Central Bank as well as other institutions (see section V for list of entities).

The workshop was preceded by the official launch of UNCTAD's [Investment Policy Review of Togo](#) with the participation of the Minister of Investment Promotion, H.E. Rose Kayi Mivedor, Ms. Binta Sanner, UNDP Togo Country Representative, Mr. Yawo Atsouvi Sikpa, Director of the Investment Promotion Agency (API-ZF) and Ms. Maha el Masri, Investment Policies Expert from UNCTAD. After the launch, H.E. Mivedor thanked UNCTAD for the continuous collaboration and formally opened the two-day workshop.

The main objective of the workshop was to strengthen the investment promotion and facilitation capacities of investment stakeholders in Togo and to provide them with tools and best practices to better target investment with a high Sustainable Development Goal (SDG) impact. In addition, and upon request of the Ministry of Investment Promotion, another objective was to foster collaboration among public entities towards a “whole-of-government” approach to investment facilitation in the country and to sensitize parties about the work of the investment promotion agency. As part of this government-wide approach, a special module was devoted to the role of diplomatic missions based overseas in investment facilitation. Among the 42 participants online were Togolese diplomats based in Brazil, Canada, China, France, Morocco and South Africa, among other countries.


The programme and topics of the workshop were decided in collaboration with the Ministry of Investment Promotion and API-ZF and focused on investments related to SDG 9 on industry, innovation and infrastructure, investment facilitation in the SDGs, SDG investment partnerships, digitalization of investment promotion and FDI statistics. The workshop was very interactive, and participants worked in groups consisting of representatives from different government entities on a series of exercises related to partnerships and improving the investment climate ecosystem in Togo.

The training was well received by participants; 70% stated that the objective of the workshop to provide information and tools to integrate the SDGs into investment promotion and facilitation was achieved at a “very high” or “high” level, while 76% stated that the objective to promote collaboration and a whole-of-government approach to investment facilitation was achieved at “very high” or “high” level. 83% stated that the workshop was “very high” or “highly” beneficial for their work (see section III for more details). The workshop included 46 in-person participants of which 8 were women and 42 online participants including Togolese diplomats posted overseas.

III. Overview and evaluation results



In person participants were asked to evaluate the workshop. Among the answers to the question, “Which aspects of the workshop did you find the most useful?” the top responses cited the usefulness of the country case studies and the sharing of best practices on SDG investments as well as the interactive exercises between actors from different government entities who were asked to think of innovative forms of collaboration to improve Togo’s investment attractiveness. Participants appreciated the modules on the digitalization of investment promotion, investment facilitation for SDGs and FDI statistics.

One interactive session which received positive response from participants was devoted to the role of diplomats in investment promotion and facilitation and included the participation of Togolese diplomats posted overseas.
