#### **Background**

It is widely recognized that achieving the Sustainable Development Goals is inextricably linked with the process of structural transformation. The UNCTAD project titled "South–South integration and the Sustainable Development Goals: Enhancing structural transformation in key partner countries of the Belt and Road initiative" identifies key policy areas in which limitations exist in government capacity in many countries to effectively design, manage, coordinate, implement and evaluate strategic economic interventions that are the policy levers of structural transformation. To address this gap, this project aims to share successful experiences from developing countries, with a view to assisting national capacity-building.

# **Purpose**

The meeting will bring together policymakers and experts from developing countries to discuss and share policy experiences in different areas, including macroeconomics, industry and trade; digital economy; and debt sustainability. Lessons that can be learned by developing countries from the successful structural transformation in China will be discussed. Participants will also benefit from the sharing of successful macrofinance policies in response to the pandemic and policies that help digital start-ups become "unicorns". This meeting will serve to launch a study prepared under the project on structural transformation in China and lessons for developing countries.
