Overview

Purpose and expected outcomes

Purpose: The workshop is organized to:

- Discuss results of pilot studies to measure illicit financial flows (IFFs) which have been carried out by six countries in Asia-Pacific during 2021-2022 under a United Nations Development Account-funded project
- Share experiences, challenges, and guidance for estimating IFFs
- Ensure efforts to measure IFFs are sustained in the project countries beyond the project

Expected outcomes: By the end of the workshop, participants:

- Are aware of what other project countries have done to estimate IFFs and able to compare their efforts, challenges, and results with the experiences in their own country
- Understand the emerging measurement guidance on crime related and commercial IFFs and can explain how they have been applied to the pilot studies
- Are aware of the interconnections of crime and commercial IFFs
- Have identified priority actions for future efforts on measuring IFFs in their country, including for continued technical work and for increased visibility among policy makers
