## Mr. Richard Chopra

#### **Senior Customs Modernization and Trade Facilitation Advisor**

Mr. Richard Chopra is a well-respected member of the global customs and trade facilitation community where he has played a vital role in delivering innovative tools and meaningful programmes.

A highly-skilled strategic advisor, organizational development and stakeholder engagement specialist, Richard is particularly known for his ability to devise and deliver solutions-oriented customs modernization and trade facilitation strategies. Richard has played a key role in the design and implementation of regional trade facilitation programmes (AEO, IT Connectivity, Border Agency Cooperation...) as well as the implementation of specific WCO standards and measures of the WTO Agreement on Trade Facilitation, including Advance Rulings, Risk Management, Authorized Operators, Time-Release studies. While at the WCO from 2012 to 2019, Richard was also involved in the update and development of WCO standards, tools and training packages related to Customs-Business Partnership, Single Window, People Development, Strategic Management, Project Management and Stakeholder Engagement.

Since 2005, Richard has been closely collaborating with the European Union, Global Alliance for Trade Facilitation, IMF, ISO, ITC, UNCTAD, UNIDO, World Bank, WCO and WTO, who all consider him an appreciated partner. He has been particularly involved with COMCEC, UNCTAD, WCO and the WTO's efforts to support the establishment and strengthening of National Trade Facilitation Committees and is the lead author of the COMCEC Handbook for Highly-Performance NTFCs.

IRU conceived TIR in 1949, and manages the system to this day.

With customs and civil service educational background, Mr. Vikentyev has 7 years experience of working at Russian customs and 8 years experience in private sector involved in foreign trade and commercial operations, legal support, and managing the customs warehouse in the latter capacity.

Mr. Vikentyev has been an external expert at OSCE and a visiting lecturer at the Russian Customs Academy and MGIMO University.
